1.0 Purpose

The University wishes to support permanent members of academic/research staff and those who have had or will expect to have 3 years of continuous employment at the time of application at **Lecturer Below/Above the Bar, or Post-Doctoral Researcher/Research Fellow** (R2 and R3) grades; who have had an extended period of leave (14 consecutive weeks or more at any point during their academic career) connected with caring – such as maternity leave, adoptive leave, paternity leave, parental leave, or leave to care for a dependent. This support is in relation to building an independent research career. It is intended that this grant will provide support to help mitigate the impact of an extended leave period on research activities.

2.0 Description

The Athena SWAN Mid-Career Lecturer/ Researcher Research Capacity Building Grant is valued at €5,000 and can be applied for at College level, via the College Research Committee. A call will be issued normally in semester two of the academic year, with a view to the successful applicants drawing down the funding by the end of August of the relevant year of award.

A specified number of grants will be made available to the Colleges each year, based on the College's size and gender composition. The initial focus of this grant scheme was to support research/scholarship capacity building for staff in STEMM as a priority, in line with the initial Athena SWAN (Ireland) agenda. This focus has now been expanded in line with the expanded Athena SWAN Charter.

The grants will be allocated by Colleges on a competitive basis including a short proposal, supported by the relevant Head of School/Director of Research Institute. The proposal should state clearly how the grant will help the individual build capacity in their independent research and should be linked directly with the School / College research strategy and with specific, time-lined, measurable research outputs. The proposed outputs and impact should be articulated and monitored in the annual PMDS process when re-established, and awardees must provide a written report (one page maximum) within 1 year of uptake of the grant to the Head of School/Director of Research Institute, copied to the Vice Dean for Research and Dean in the relevant College.

Academic staff who have availed of the <u>Research Grant for Returning Academic Carers'</u> are not eligible to apply for the Athena SWAN Mid-career Lecturer/ Researcher Research Capacity Building grant. Academic/Research staff who have been awarded the Athena SWAN Mid-career Lecturer Research Capacity Building grant in the past 5 years are not eligible to apply again.
