

# THE CENTRE FOR HOUSING LAW, RIGHTS AND POLICY (CHLRP)

Housing law, rights and policy are now global issues. Here, at the Centre for Housing Law, Rights and Policy Research (CHLRP), we endeavour to create a space for a free and open discussion, combining research, resource development, advocacy and publications on housing law, rights and policy in Ireland, and internationally. The Centre is linked with many international organisations, such as the European Network of Housing Researchers, and the UNESCO Housing Chair in Tarragona, Spain, hosting visiting professors, researchers and IRC-funded PhD students.

We aim to contribute to the development of housing law, rights and policy through research, conferences, lectures, training, advocacy, publications, specialist research and support to housing agencies and others.

Current areas of research include housing rights in global housing markets, developing legislation on proportionality in housing, European mortgage market regulation and consumer protection, applying EU Charter housing rights to EU economic governance institutions, regulation of housing systems, and addressing implementation deficits in housing law and policy.

# LAW POSTGRADUATE TAUGHT PROGRAMMES New Course LLM Law and Digital Innovation

The LLM in Law and Digital Innovation is the only Masters of its kind in the Republic of Ireland. The use of technology, software tools and artificial intelligence are transforming legal practice and creating new career opportunities. Employers are keen to hire individuals with skills in both law and technology. The LLM in Law and Digital Innovation responds to this through the provision of high quality, research-led teaching that bridges the disciplines of law, information systems, and data analytics.

This programme will be of interest to law, business or STEM graduates who are seeking to develop a career in lawtech, and legal practitioners who are seeking to upskill or change careers.

# Course Highlights:

- A diverse range of cross-disciplinary and research-led modules that focus on topics at the intersection of law, information systems and data analytics, delivered by leading experts.
- Guest lecturers from those involved in creating, applying or experiencing the use of technology in legal practice and in the courts.
- · Field trips to important sites of practice, such as the Courts Service.
- The Technology and Rights Research Cluster which has links with (inter)governmental, judicial and civil society organisations will enable students to attend a range of events hosted by this cluster.
- Applied Design Thinking Project, addressing a real-life problem under the supervision of a specific supervisor. This project will take place across Semester I and II, as part of the module Design Thinking for Lawyer I and II. Students will be presented with a highly complex legal issue presented by real life stakeholders, and will have agency to choose what aspect they wish to address. Over the course of two semesters they will define personas, and develop solutions for those personas, ultimately developing a solution which they will prototype, test and iterate. Additionally students will consider the audience and marketing of this solution
- A Minor Thesis is completed by students on a topic of their choice under close supervision by leading experts.
- Focus on skills and employability including legal research and writing, data analytics, and app development.

Career Support is provided through professional workshops concentrating on students CV and interview skills. 'Careers in Law Week' also provides an opportunity to meet potential employers.


# Career Opportunities:

Al might not replace lawyers, but lawyers with skills in technology and analytics will have an advantage in the job market, particularly noted by Wolters Kluwer in 2023, is a need to understand and apply Generative AI. Graduates might work as lawyers in traditional legal advice roles, particularly focusing on technology law, or in other roles such as Legal Technologist, Legal Process Analyst, Legal Knowledge Engineer, Legal Hybrid, Legal Project Manager, Online Dispute Resolution Practitioner, Legal Risk Manager, Legal Prompt Engineer and Legal Management Consultant. The more enterprising might become lawtech entrepreneurs.

For those who are interested in working directly on lawtech, according to a Robert Walters report on the lawtech job market, vacancies in this field have grown by 87% between 2019 to 2020, and 177% between 2020 and 2021. By 2021, lawtech jobs were 2.7% of all tech vacancies in the UK. For more traditional roles, according to a Wolters Kluwer report the increasing importance of legal technology was one of the key trends that will impact on legal professionals from 2023-26, while a lack of technology skills is an issue for 49% of the firms surveyed yet legal departments that are technology leaders routinely outperform those who are not. 75% of firms and legal departments reported they are prepared and expect to invest in technologies in 2023.

Potential employers who hire experts within these fields include traditional legal firms, accountancy and consultancy firms, and lawtech firms. Career paths are also possible with the civil and public

service (particularly the courts), as an barrister, or as an in-house lawyer in a commercial organisation (particularly multi-national businesses). Students who have completed the specialised modules

# LAW POSTGRADUATE TAUGHT PROGRAMMES LLM Criminology, Criminal Justice and Human Rights

# The LLM in Criminology, Criminal Justice and Human Rights will be delivered by staff from the Crime, Punishment and Rights Research Cluster at the School of Law and the Irish Centre for Human Rights.

The programme recognises the inescapable reality that criminal justice issues cannot be understood without also understanding underpinning human rights law norms and obligations.

The programme has been designed to inspire students coming from either directly from study or from practice to engage in life-long-learning, to uphold high ethical and professional standards and to appreciate the need to advocate for and adopt an evidence-informed and rights-based approach to criminal justice issues.

The programme's curriculum emphasises inter-disciplinary intersections and research methods training, to facilitate future or enhanced career possibilities in national, regional and international criminal justice agencies, NGOs, inter-governmental organisations and courts.

# Course Highlights:

- A diverse range of cross-disciplinary and research-led modules that focus on topics at the intersection of law, criminology, criminal justice and rights, delivered by leading experts.
- Visits to criminal justice institutions including Limerick Prison, provide students with insights into the reality of criminal justice and penal policy operationalisation.
- Crime, Punishment and Rights
   Seminar Series will allow students to
   hear first-hand from guest lecturers
   involved in creating and applying
   criminal justice law and policy. The
   seminar series is organised by
   the Crime, Punishment and Rights
   Research Cluster at the School

# Career Opportunities:

This LLM programme was developed following consultations with a range of potential employers in this field. It has therefore been designed to equip graduates with the essential skills and knowledge they need to pursue a successful national or international career within the fields of criminology, criminal justice and human rights. Graduates may opt to pursue work in legal practice, policy development, advocacy or research in criminal justice broadly or focus on particular career paths such as with prison or police services, or with regional or international organisations or courts.

Potential employers who hire experts within these fields include national organisations like the Director of Public Prosecutions (DPP), the Policing Authority, Irish Penal Reform Trust, the Irish Prison Service and the Department of Justice. Career paths are also possible with international organisations such as the Council of Europe and the United Nations and with international criminal courts and tribunals.

# The LLM in International and Comparative Business Law provides an excellent grounding in business law, for those interested in pursuing a career in legal practice or in the commercial world. Students can choose from a range of modules at an advanced level and tailor their LLM to suit their interests and career pathway. Students will expand their knowledge of business law from a global perspective through lectures, seminars, conferences and opportunities to engage with leading commercial practitioners.



# Course Highlights:

- Prestigious Placements opportunity to apply for a limited number of placements with leading commercial law firms. Selection is on the basis of interview by the firm.
- Focus on Skills and Employability to equip students with key business skills including critical thinking, drafting legal submissions, negotiation, advocacy and mediation.
- Expert Lecturers deliver this programme through small group seminars with guest talks from leading practitioners. Students also have the opportunity to attend and present at key conferences, nationally and internationally as well as participate in moot court competitions.

The LLM in Transitional Justice, Human Rights and Conflict examines the complex legal, policy and practical questions of justice and peacebuilding in societies emerging from conflict, authoritarianism or situations of mass human rights violations. This innovative programme will provide an interdisciplinary approach to teaching and researching the world's most pressing issues on transitional justice, peacebuilding and reconciliation.

The programme will be of interest to those seeking to pursue advanced studies in transitional justice, human rights, postconflict reconstruction and peacebuilding. It will provide students with the knowledge and skills needed to engage with issues of transitional justice and peacebuilding in the aftermath of gross human rights violations, such as forced disappearances, arbitrary detention, torture, genderbased and sexual violence in conflict, and genocide.

# Doctoral Studies (PhD)

The School of Law and its specialised research centres, notably, the Irish Centre for Human Rights and the Centre for Disability Law and Policy, offer structured PhD programmes in law.

The Structured PhD is available as a 4-year Full Time programme or a 6 -year Part Time programme(360 ECTS). Each student must obtain a total of 30 ECTS through structured modules having a taught or skills component, over the course of the PhD and the remaining 330 ECTS are awarded for the Dissertation. The thesis remains central to the award of the PhD. The remaining ECTS are derived from the research component.

# Immigration Regulations

Students from EU and EEA member states do not require a visa to study in Ireland.

Students from Non EU member states are required to comply with Irish Visa and Immigration regulations. It is important that you obtain and maintain a valid passport and Study Visa to enter Ireland for study purposes.

# The Graduate Permit Scheme

The Graduate Permit Scheme allows legally resident Irish educated non-EU/EEA graduates holding an award of a recognised Irish awarding body to remain in Ireland after their studies.

The Irish Government has extended the scheme for non-EU/EEA students at Level 9 and above of the National Framework of Qualifications.
