#### STATUTE CCIX

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

Given under the Common Seal of University College, Galway, this twenty-third day of January, One Thousand Nine Hundred and Ninety-one.

# SCHEDULE — STATUTE CCIX

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

#### **CHAPTER I**

1. There shall be established in the College, in the event of their institution by the Senate of the National University of Ireland, the following full-time Associate Professorships:

Associate Professorship of Economics Associate Professorship of Botany Associate Professorship (No. 2) of Zoology Associate Professorship (No. 3) of History.

- 2. The annual stipend attaching to the foregoing Associate Professorships shall be the same as that attaching from time to time to the fulltime Associate Professorships of the College.
  - 3. The holder of the Associate Professorship of Economics shall carry out his duties under the direction of the Professor of Economics.
  - 4. The holder of the Associate Professorship of Botany shall carry out his duties under the direction of the Professor of Botany.
  - 5. The holder of the Associate Professorship (No. 2) of Zoology shall carry out his duties under the direction of the Professor of Zoology.
  - 6. The holder of Associate Professorship (No. 3) of History shall carry out his duties under the direction of the Professor of History.
  - 7. The foregoing Associate Professorships shall be pensionable offices in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII and CCVII, University College, Galway.
  - 8. The holder of each of the said Associate Professorships shall, subject to good conduct and the due fulfilment of his duties, continue in office until he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years: **provided** that such further continuance in office be recommended to the Senate of the National University of Ireland by the Governing Body with the approval of the President and be sanctioned annually by the said Senate.
  - 9. On the occurrence of a vacancy in Lectureship (No.2) in Economics, the said Lectureship shall thereupon be abolished.

- 10. On the occurrence of a vacancy in Lectureship (No. 6) in Botany, the said Lectureship shall thereupon be abolished.
- 11. On the occurrence of a vacancy in Lectureship (No. 4) in Zoology, the said Lectureship shall thereupon be abolished.
- 12. On the occurrence of a vacancy in Lectureship (No. 4) in History, the said Lectureship shall thereupon be abolished.

### **CHAPTER II**

- 1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
- 2. This Statute shall come into operation on the twenty-third day of January, One Thousand Nine Hundred and Ninety-one, and may be cited as Statute CCIX, University College, Galway, or Stat. CCIX, Univ. Coll., Galway.
