WE, the Governing Body of University College, Gaiway, under and by virtue of the powers in that behalf conferred on us by the above Acts DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

SCHEDULE—STATUTE LXV

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

LECTURESHIP IN ECONOMICS, COMMERCE, and ACCOUNT-ANCY, LECTURESHIP IN BIOCHEMISTRY, LECTURESHIP IN CELTIC ARCHAEOLOGY.

- The Lectureship in Economics, Commerce and Accountancy established by Chapter XIII of Statute XVII of University College, Galway, is hereby extinguished, and in lieu thereof there shall be established in the College (in the event of their institution by the Senate of the National University of Ireland) two full-time Lectureships as follows:—
 - (i) Léachtóireacht ar Gheilleagar agus Tráchtáil.
 - (ii) Léachtóireacht ar Chuntasaíocht.
 - The holders of the foregoing Lectureships shall carry out the duties of their respective Lectureships under the direction of the Professor of Economics, Commerce and Accountancy.
- 2. There shall be established in the College in the event of their institution by the Senate of the National University of Ireland the following full-time Lectureships:—(i) A Lectureship (No. 2) in Biochemistry; the holder shall carry out the duties of the Lectureship under the direction of the Professor of Biochemistry; (ii) A Lectureship in Celtic Archaeology; the holder shall carry out the duties of the Lectureship under the direction of the Professor of Celtic Archaeology.
- 3. The annual stipend of the holder of each of the foregoing full-time Lectureships shall be £1,955 on appointment increasing

to a maximum of £2,760 by annual increments of £80 10s. 0d. for each completed year of service since appointment. The Governing Body may in its discretion in accordance with Chapter II of Statute LIV of University College, Galway and if the President (having regard to the qualifications and College service of any of the persons appointed) so recommends fix the commencing stipend of the Lectureship at any point in the

incremental salary scale applicable thereto.

4. The holder of each of the foregoing four Lectureships shall subject to good conduct and to the due fulfilment of his duties hold office for seven years after which he shall be eligible for reappointment. If re-appointed he shall subject to good conduct and the due fulfilment of his duties hold office until he shall have attained the age of sixty-five years and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office is recommended to the Senate of the National University of Ireland by the Governing Body with the approval of the President and is sanctioned annually by the said Senate.

5. (a) The foregoing four Lectureships shall be pensionable offices within the meaning of Chapter XXV of Statute XVII of University College, Galway, and the amendments thereto and shall be annexed to the appropriate Table of the Pension Scheme. The holder of each Lectureship shall be entitled to payment of both Pension and Gratuity under and in accordance with the provisions of Chapter II and Chapter III of Statute XXXVI of University College,

Galway and of the Statutes of the College.

(b) The annual stipend for the purpose of calculating Pension and Gratuity in accordance with the relevant provisions of existing Statutes of the College shall be that payable at date of retirement or death of the holder.

(c) There shall be paid into the Pension Fund such additional sum as an Actuary shall certify to be necessary for providing

such Pension and Gratuity as aforesaid.

6. The holder of each of the foregoing four Lectureships shall be entitled to the annual allowance in respect of a wife and ehildren payable pursuant to Statute XXXVII and Statute LV of University College, Galway.

CHAPTER II

 Nothing herein contained shall affect any appointment made, right acquired, or act done under any previous Statute of the College.

2. This Statute shall come into operation on the Fifteenth day of June, One Thousand Nine Hundred and Sixty-six and may be sited as Statute LXV, University College, Galway or Stat. LXV. Univ. Coll. Galway.
