STATUTE CCCLXVIII/*REACTH CCCLXVIII*

WE, Údarás na hOllscoile of National University of Ireland, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of National University of Ireland, Galway, make the Statute contained in the Schedule hereto for the general government of the said University./*Faoi agus de bhua na gcumhacht sin a bheirtear dúinn ag na hAchtanna thuasluaite, déanaimidne, Údarás na hOllscoile ag Ollscoil na hÉireann, Gaillimh, tríd an ionstraim seo faoi Shéala Ollscoil na hÉireann, Gaillimh, an Reacht atá sa Sceideal seo thíos chun rialú ginearálta na hOllscoile sin.*

Schedule – STATUTE CCCLXVIII/*Sceideal* – *REACTH CCCLXVIII*

All previous Statutes of National University of Ireland, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth./*Déanfar Reachtanna uile Ollscoil na hÉireann, Gaillimh, roimhe seo a léamh agus a fhorléiriú maille leis na hathruithe, na breisithe agus na modhnuithe atá leagtha amach ina dhiaidh seo thíos.*

CHAPTER I

PERSONAL AND ESTABLISHED PROFESSORSHIPS

Statute CCCLXVIII hereby sets out the common conditions of service attaching henceforth both to Personal and Established Professorships in place of individual statutes delineating the same said conditions in respect of specific Professorship posts titled heretofore. Statute CCCLXVIII shall henceforth be a generic statute for professorial posts.

1. The annual stipend attaching to Professorships shall be the same as that attaching from time to time to the fulltime Personal or Established Professorships of the University.
2. The Personal and Established Professorships shall be pensionable offices in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.
3. Subject to the terms of the Employment Control Framework currently in operation in the University under direction from the Higher Education Authority, or as such terms may be amended hereafter, the holders of Personal and Established Professorships shall, subject to good conduct, a satisfactory probation period of two years and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years: PROVIDED that (1) in the case of an appointee who is deemed to be a 'new entrant' to the public service in accordance with the provisions of the Public Service Superannuation (Miscellaneous Provisions) Act 2004 shall not be entitled to retire before attaining the age of sixty-five years and shall not be obliged to retire on the grounds of having attained the age of sixty-five years, or (2) in the case of an appointee who is deemed to be a 'new recruit' from 1 January, 2013 to the public service in accordance with the provisions of the Public Service Pensions (Single Scheme and Other Provisions) Act 2012, shall not be entitled to retire before attaining the age of sixty-six years from 1 January, 2014, rising in line with the statutory state pension age to sixty-seven years from 1 January 2021 and sixty-eight years from 1 January 2028 and shall not be obliged to retire before attaining the age of seventy years.
4. The holders of the said Professorships shall carry out the duties attaching to Professorships under the direction of such Head of School as Údarás na hOllscoile shall from time to time deem appropriate.

CHAPTER II

SENIOR LECTURESHIP

Statute CCCLXVIII hereby sets out the common conditions of service attaching henceforth to Senior Lectureships in place of individual statutes delineating the same said conditions in respect of specific Senior Lectureship posts titled heretofore. Statute CCCLXVIII shall henceforth be a generic statute for Senior Lectureship posts.

1. The annual stipend attaching to Senior Lectureships shall be the same as that attaching from time to time to the fulltime Senior Lectureships of the University.
2. The Senior Lectureship shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.
3. Subject to the terms of the Employment Control Framework currently in operation in the University under direction from the Higher Education Authority, or as such terms may be amended hereafter, the holders of a Senior Lectureship shall, subject to good conduct, a satisfactory probation period of two years, and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years: PROVIDED that (1) in the case of an appointee who is deemed to be a 'new entrant' to the public service in accordance with the provisions of the Public Service Superannuation (Miscellaneous Provisions) Act 2004 shall not be entitled to retire before attaining the age of sixty-five years and shall not be obliged to retire on the grounds of having attained the age of sixty-five years, or (2) in the case of an appointee who is deemed to be a 'new recruit' from 1 January, 2013 to the public service in accordance with the provisions of the Public Service Pensions (Single Scheme and Other Provisions) Act 2012, shall not be entitled to retire before attaining the age of sixty-six years from 1 January, 2014, rising in line with the statutory state pension age to sixty-seven years from 1 January 2021 and sixty-eight years from 1 January 2028 and shall not be obliged to retire before attaining the age of seventy years.
4. The holders of a Senior Lectureship shall carry out the duties attaching to Senior Lectureships under the direction of such Head of School as Údarás na hOllscoile shall from time to time deem appropriate.

CHAPTER III

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.
2. This Statute shall come into operation on the twenty-eighth Day of June, Two Thousand and Nineteen, and may be cited as Statute CCCLXVIII, National University of Ireland, Galway, or Stat. CCCLXVIII, Nat. Univ. of I., Galway.
