STATUTE CCCXVIII

WE, Údarás na hOllscoile of National University of Ireland, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of National University of Ireland, Galway, make the Statute contained in the Schedule hereto for the general government of the said University.

Schedule - STATUTE CCCXVIII

All previous Statutes of National University of Ireland, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

ESTABLISHED PROFESSORSHIP

1. There is hereby established in the University the following fulltime Established Professorship:

Established Professorship of Midwifery.

2. The annual stipend attaching to the foregoing Established Professorship shall be the same as that attaching from time to time to the fulltime Established Professorships of the University.
3. The said Established Professorship shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.
4. Subject to the terms of the Employment Control Framework currently in operation in the University under direction from the Higher Education Authority, or as such terms may be amended hereafter, the holder of the said Established Professorship shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years, PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile, and PROVIDED further that, in the case of an appointee who is deemed to be a "new entrant" to the public service in accordance with the provisions of the Public Service Superannuation (Miscellaneous Provisions) Act 2004, a holder of the said Professorship shall not be entitled to retire before attaining the age of sixty-five years and shall not be obliged to retire on the grounds of having attained the age of sixty-five years.
5. The holder of the said Established Professorship shall carry out the duties of the Established Professorship under the direction of such Head of School as Údarás na hOllscoile shall from time to time deem appropriate.

CHAPTER II

PERSONAL PROFESSORSHIPS

1. There are hereby established in the University the following Personal Professorships:

Personal Professorship of Marine Biodiscovery Personal Professorship of Midwifery.

2. The annual stipend attaching to each of the foregoing Personal Professorships shall be the same as that attaching from time to time to the fulltime Personal Professorships of the University.

3. Each of the said Personal Professorships shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.
4. Subject to the terms of the Employment Control Framework currently in operation in the University under direction from the Higher Education Authority, or as such terms may be amended hereafter, the holder of each of the said Personal Professorships shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years : PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile, and PROVIDED further that, in the case of an appointee who is deemed to be a "new entrant" to the public service in accordance with the provisions of the Public Service Superannuation (Miscellaneous Provisions) Act 2004, a holder of each of the said Personal Professorships shall not be entitled to retire before attaining the age of sixty-five years and shall not be obliged to retire on the grounds of having attained the age of sixty-five years.
5. The holder of each of the said Personal Professorships shall carry out the duties of the Personal Professorship under the direction of such Head of School as Údarás na hOllscoile shall from time to time deem appropriate.

CHAPTER III

SENIOR LECTURESHIPS

1. There are hereby established in the University the following fulltime Senior Lectureships:

Senior Lectureship in Marine Biodiscovery
Senior Lectureship in Midwifery.
2. The annual stipend attaching to each of the foregoing Senior Lectureships shall be the same as that attaching from time to time to the fulltime Senior Lectureships of the University.
3. Each of the said Senior Lectureships shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII, and CCXXVI , National University of Ireland, Galway.
4. Subject to the terms of the Employment Control Framework currently in operation in the University under direction from the Higher Education Authority, or as such terms may be amended hereafter, the holder of each of the said Senior Lectureships shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na

hOllscoile, and PROVIDED further that, in the case of an appointee who is deemed to be a “new entrant” to the public service in accordance with the provisions of the Public Service Superannuation (Miscellaneous Provisions) Act 2004, a holder of each of the said Senior Lectureships shall not be entitled to retire before attaining the age of sixty-five years and shall not be obliged to retire on the grounds of having attained the age of sixty-five years.

5. The holder of each of the said Senior Lectureships shall carry out the duties of the Senior Lectureship under the direction of such Head of School as Údarás na hOllscoile shall from time to time deem appropriate.

CHAPTER IV

ACADEMIC COUNCIL

1. Statute CCLIV, Chapter I, as amended by Statute CCLXIII, Chapter II, by Statute CCLXXIX, Chapter III, by Statute CCLXXXVIII, Chapter I, and by Statute CCXCIII, Chapter III, is hereby further amended by the addition of the following Paragraphs to Section 1 thereof:

“(xxi) The Director of Quality
(xxii) The President of the Students’ Union”.

CHAPTER V

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.
2. This Statute shall come into operation on the fifteenth day of October, Two Thousand and Ten, and may be cited as Statute CCCXVIII, National University of Ireland, Galway, or Stat. CCCXVIII, Nat. Univ. of I., Galway.
