STATUTE CCII

We, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

Given under the Common Seal of University College, Galway, this twenty-fourth day of June, One Thousand Nine Hundred and Eighty-eight.

SCHEDULE — STATUTE CCII

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CAIBIDIL I

1. Gairmfear uaidh seo amach an Chomhollúnacht (Uimh. 3) le Bithcheimic agus an Chomhollúnacht (Uimh. 2) le Matamaitic, faoi seach, de na Comhollúnachtaí a bunaíodh le Reacht LXXVI.
2. Comhlíonfaidh sealbhóir na Comhollúnachta (Uimh. 3) le Bithcheimic a dhualgais faoi stiúru an Ollaimh le Bithcheimic.
3. Comhlíonfaidh sealbhóir na Comhollúnachta (Uimh. 2) le Matamaitic a dhualgais faoi stiúru an Ollaimh le Matamaitic.

CAIBIDIL II

1. Gairmfear uaidh seo amach an Chomhollúnacht (Uimh. 3) le Ceimic den Chomhollúnacht a bunaíodh le Reacht CVI.
2. Comhlíonfaidh sealbhóir na Comhollúnachta (Uimh. 3) le Ceimic a dhualgais faoi stiúru an Ollaimh le Ceimic.

CAIBIDIL III

1. Ni dhéanfaidh aon ní anseo difear d'aon cheapachán a rinneadh, d'aon cheart a fuarthas ná d'aon ghníomh a rinneadh faoi aon Reacht den Choláiste roimhe seo.

CHAPTER I

1. The Associate Professorships established by Statute LXXVI shall henceforth be known as the Associate Professorship (No. 3) of Biochemistry and the Associate Professorship (No. 2) of Mathematics, respectively.
2. The holder of the Associate Professorship (No. 3) of Biochemistry shall carry out his duties under the direction of the Professor of Biochemistry.
3. The holder of the Associate Professorship (No. 2) of Mathematics shall carry out his duties under the direction of the Professor of Mathematics.

CHAPTER II

1. The Associate Professorship established by Statute CVI shall henceforth be known as the Associate Professorship (No. 3) of Chemistry.
2. The holder of the Associate Professorship (No. 3) of Chemistry shall carry out his duties under the direction of the Professor of Chemistry.

CHAPTER III

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
