STATUTE CCLIV

We, Údarás na hOllscoile of National University of Ireland, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of National University of Ireland, Galway, make the Statute contained in the Schedule hereto for the general government of the said University.

Given under the Common Seal of National University of Ireland, Galway, this eighteenth day of May, One Thousand Nine Hundred and Ninety-eight.

SCHEDULE - STATUTE CCLIV

All previous Statutes of National University of Ireland, Galway and in particular Statute XVII, Chapter X, Section 1 shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

THE ACADEMIC COUNCIL

1. The members of the Academic Council shall be:
 - (i) The President
 - (ii) The Registrar
 - (iii) The Dean of each Faculty
 - (iv) The Professors
 - (v) Any person, other than a Professor, who is the Head for the time being of an academic Department or of a School or of an academic discipline as determined by the Governing Body following consultation with the Academic Council
 - (vi) The Associate Professors
 - (vii) The Lecturers who were members of the Academic Council holding office immediately before the coming into operation of this Statute
 - (viii) Five Lecturers elected by the Lecturers
 - (ix) Five College Lecturers elected by the College Lecturers
 - (x) Five Junior Lecturers elected by the Junior Lecturers
 - (xi) Five students, of whom three shall be undergraduate students and two postgraduate students, elected by the students
 - (xii) The Librarian
 - (xiii) The Director of Computer Services
 - (xiv) The Director of Adult and Continuing Education
 - (xv) Stiúrthóir na Gaeilge Labhartha
 - (xvi) Such Lecturers as may be coopted as members, in the event that any of the Lecturers who are members by virtue of Paragraph (vii) of this Section ceases to be a member by virtue of that Paragraph or for any other reason, provided that the number of Lecturers so coopted, together with the Lecturers who are members by virtue of that Paragraph, shall not exceed the number of Lecturers who were members by virtue of that Paragraph on the date of the coming into operation of this Statute.
2. The members elected under Paragraphs (viii), (ix), (x) and (xi), respectively, of Section 1 of this Chapter shall include in each case at least one woman and at least one man, subject to the candidates' including in each case at least one woman and at least one man, respectively.

3. Each member elected under Paragraphs (viii), (ix) and (x) of Section 1 of this Chapter and any member coopted under Paragraph (xvi) of the said Section shall hold office for three years.
4. A Lecturer, College Lecturer or Junior Lecturer shall not be eligible for election under Paragraphs (viii), (ix) or (x), respectively, of Section 1 of this Chapter as a member for a third consecutive term of office.
5. Each member elected under Paragraph (xi) of Section 1 of this Chapter shall hold office for one year.
6. Any Professor or Lecturer who was a member of the Academic Council holding office immediately before the coming into operation of this Statute may, by notice in writing to the Secretary of the Academic Council, relinquish his/her membership of the Council.

CHAPTER II

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.
2. This Statute shall come into operation on the eighteenth day of May, One Thousand Nine Hundred and Ninety-eight, and may be cited as Statute CCLIV, National University of Ireland, Galway, or Stat. CCLIV, N.U.I., Galway.
