**STATUTE CCLXIII**

We, Údarás na hOllscoile of National University of Ireland, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of National University of Ireland, Galway, make the Statute contained in the Schedule hereto for the general government of the said University.

**SCHEDULE - STATUTE CCLXIII**

All previous Statutes of National University of Ireland, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.



## CHAPTER I

### NEW LECTURESHIP

1. There is hereby established in the University the following fulltime Lectureship:  
**Lectureship in Medical Informatics and Medical Education.**
2. The annual stipend attaching to the foregoing Lectureship shall be the same as that attaching from time to time to the fulltime Lectureships of the University.
3. The said Lectureship shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.
4. The holder of the said Lectureship shall, in accordance with the provisions of Statute CXCIV, subject to good conduct and the due fulfilment of his/her duties and to having served a probationary period of two years in the said office to the satisfaction of Údarás na hOllscoile, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years : **PROVIDED** that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile.
5. The holder of the said Lectureship shall carry out the duties of the Lectureship under the direction of the Professor of Medicine.
6. The Lectureship in Experimental Medicine is hereby abolished, with effect from the date of an appointment to the foregoing Lectureship.

## CHAPTER II

### THE ACADEMIC COUNCIL

1. Statute CCLIV, Chapter I is hereby amended as follows:
  - a) In Section 1, Paragraph (xi) by the substitution of the words "elected by the students in a manner to be determined from time to time by the Academic Council, following consultation with the Students' Union" for the words "elected by the students" therein.



- b) In Section 5 by the substitution of the following words for the words "hold office for one year" therein:

"hold office for the duration of the academic year.  
A member elected to fill a casual vacancy  
occurring during the academic year shall hold  
office for the remainder of that academic year".

### CHAPTER III

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.
2. This Statute shall come into operation on the eighth day of May, Two Thousand, and may be cited as Statute CCLXIII, National University of Ireland, Galway, or Stat. CCLXIII, Nat. Univ. of I., Galway.
