#### STATUTE CCLXII

We, Údarás na hOllscoile of National University of Ireland, Galway, under and by irtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of National University of Ireland, Galway, make the Statute contained in the Schedule hereto for the general government of the said University.

Given under the Common Seal of National University of Ireland, Galway, this third day of December, One Thousand Nine Hundred and Ninety-nine.

#### SCHEDULE - STATUTE CCLXII

All previous Statutes of National University of Ireland, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

#### CHAPTER I

### **Appointment of President**

- 1. (a) The President shall be appointed by Údarás na hOllscoile, after consideration of a report from an Assessment Board appointed by Údarás na hOllscoile for the purpose.
  - (b) The Assessment Board shall carry out such interview and other procedures as shall be determined by Údarás na hOllscoile and which, in the opinion of Údarás na hOllscoile, shall best ensure participation in the selection process by high-quality candidates from both within and outside of the University.
- The provisions of Sections 2, 3 and 4 of Statute XXXII, Sections 3, 7 and 8 of Statute XXIII and Section 1 of Chapter I of Statute CCXLIV, in regard to competency to discharge the duties of the Office through the medium of the Irish language, shall apply to the appointment of the President. The candidate or candidates from among whom Údarás na hOllscoile shall make the appointment shall possess the Irish language qualification and shall also be suitable in all other respects.
  - 3. (a) Údarás na hOllscoile shall also appoint a Search Committee.
    - (b) The Search Committee shall carry out such procedures, including public advertisement, as shall be determined by Údarás na hOllscoile and which, in the opinion of Údarás na hOllscoile, shall best ensure participation in the selection process by high-quality candidates from both within and outside of the University.

#### **CHAPTER II**

- Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.
- This Statute shall come into operation on the third day of December, One Thousand Nine Hundred and Ninety-nine, and may be cited as Statute CCLXII, National University of Ireland, Galway, or Stat. CCLXII, Nat. Univ. of I., Galway.
