STATUTE CCLXIV

We, Údarás na hOllscoile of National University of Ireland, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of National University of Ireland, Galway, make the Statute contained in the Schedule hereto for the general government of the said University.

SCHEDULE - STATUTE CCLXIV

All previous Statutes of National University of Ireland, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

PROFESSORSHIP OF INFORMATION TECHNOLOGY

1. The existing fulltime office in the University entitled “the Director of Information Technology” or “the Director of Information Technology Centre” is hereby re-titled as the fulltime office of “The Professorship of Information Technology” and, accordingly, the said fulltime office of Professorship of Information Technology is hereby established.
2. The annual stipend attaching to the foregoing office of the Professorship of Information Technology shall be the same as that attaching from time to time to the fulltime Professorships of the University.
3. The said office of the Professorship of Information Technology shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.
4. The holder of the said office of the Professorship of Information Technology shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years : **PROVIDED** that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile.
5. For the avoidance of doubt, it is hereby declared that the holder of the office of the Director of Information Technology or the Director of Information Technology Centre at the date of coming into effect of this Statute, shall continue to be the holder of the office re-titled hereby as the Professorship of Information Technology and the rights and entitlement of such person in respect of tenure, remuneration, fees, allowances, expenses and superannuation as an employee of the University shall not be affected hereby.
6. All references in existing Statutes or other documents relating to the Director of Information Technology or to the Director of Information Technology Centre shall, after the coming into effect of this Statute, be construed as referring to the Professorship of Information Technology.
7. The existing Information Technology Centre is hereby retitled as the Department of Information Technology. All references in existing documents to the Information Technology Centre shall, after the coming into effect of this Statute, be construed as referring to the Department of Information Technology.

CHAPTER II

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.
2. This Statute shall come into operation on the eighth day of May, Two Thousand, and may be cited as Statute CCLXIV, National University of Ireland, Galway, or Stat. CCLXIV, Nat. Univ. of I., Galway.
