STATUTE CCLXV

We, Údarás na hOllscoile of National University of Ireland, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of National University of Ireland, Galway, make the Statute contained in the Schedule hereto for the general government of the said University.

SCHEDULE - STATUTE CCLXV

All previous Statutes of National University of Ireland, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

THE OFFICE OF PRESIDENT

1. There is hereby established in the University a fulltime Professorship (Untitled) with such functions as Údarás na hOllscoile, following recommendation from the Academic Council, shall decide from time to time.
2. The holder of the foregoing Professorship shall be a former holder of the Office of President who, having served as President for a period of ten years and not having attained the age of sixty-five years, does not retire and is deemed by Údarás na hOllscoile, following recommendation from the Academic Council, to be suitable to hold the said Professorship.
3. The annual stipend attaching to the said Professorship shall be the maximum rate of stipend attaching from time to time to the fulltime Professorships of the University : **PROVIDED** that the amount of any pension, calculated in accordance with the provisions of the Statutes of the University, payable to the holder on ceasing to hold the Office of President as aforesaid and the amount of the stipend attaching to the Professorship hereby established shall not, in aggregate, exceed eighty per cent of the stipend of the Office of President and, if necessary, the said stipend shall be reduced accordingly.
4. The holder of the said Professorship shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and shall then retire.
5. The said Professorship shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI and of this Statute : **PROVIDED** that the final salary on which any pension relating to the said Professorship is calculated shall be the maximum rate of stipend attaching to the fulltime Professorships of the University from time to time.
6. The provisions of Statute CLXI are hereby amended as follows:
 - (a) by the substitution of the following Subsection for Subsection 7(a)(i) of Chapter II thereof:

“7(a)(i). The President shall hold office for a period of ten years or for the period until (s)he shall have attained the age of sixty-five years, whichever period shall first expire. On retiring on the date of ceasing to hold office, the former President shall be entitled to a pension in accordance with the provisions of Statute CLXI and the Pension Scheme annexed thereto. Alternatively, should the former President not retire and be appointed to

the Professorship established by Statute CCLXV, Chapter I, and is under the age of sixty years, the said pension shall be subject to the provisions regarding the payment of preserved pensions as set out in Statute CLXI, Chapter IV.

Notwithstanding the foregoing, the President, provided that (s)he shall have attained the age of sixty years, and provided further that (s)he shall have completed not less than five years in the office of President, may retire on pension at any time within five years of the expiration of his/her period of office, provided that at least three months' notice in writing of his/her intention to so retire must be given to the Secretary of the University, such three months to be exclusive of the months of July, August and September".

- (b) by the addition of the following words to Subsection 3(a) of Chapter III thereof:

"PROVIDED that, in the case of a President who dies while holding the Office of President and who would have been eligible for appointment to the Professorship established by Statute CCLXV, Chapter I, the annual pension of the spouse shall be calculated as if the said President had been appointed to the said Professorship and had died on attaining the age of sixty-five years".

CHAPTER II

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.
2. This Statute shall come into operation on the eighth day of May, Two Thousand, and may be cited as Statute CCLXV, National University of Ireland, Galway, or Stat. CCLXV, Nat. Univ. of I., Galway.
