**STATUTE CCLXXIX**

WE, Údarás na hOllscoile of National University of Ireland, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of National University of Ireland, Galway, make the Statute contained in the Schedule hereto for the general government of the said University.

**SCHEDULE - STATUTE CCLXXIX**

All previous Statutes of National University of Ireland, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

## CHAPTER I

### NEW PROFESSORSHIPS

1. There are hereby established in the University the following fulltime Professorships:

**Professorship of Occupational Therapy**  
**Professorship of Speech and Language Therapy.**

2. The annual stipend attaching to each of the foregoing Professorships shall be the same as that attaching from time to time to the fulltime Professorships of the University.
3. Each of the said Professorships shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.
4. The holder of each of the said Professorships shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years : PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile.
5. The holder of each of the said Professorships shall cooperate with other Departments and Units of the University in such manner as shall be determined from time to time by Údarás na hOllscoile, following consultation with the Academic Council.

## CHAPTER II

### NEW SENIOR LECTURESHIPS

1. There are hereby established in the University the following fulltime Senior Lectureships:

**Senior Lectureship in Occupational Therapy**  
**Senior Lectureship in Speech and Language Therapy.**

2. The annual stipend attaching to each of the foregoing Senior Lectureships shall be the same as that attaching from time to time to the fulltime Senior Lectureships of the University.
3. Each of the said Senior Lectureships shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.

4. The holder of each of the said Senior Lectureships shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years : PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile.
5. The holder of the said Senior Lectureship in Occupational Therapy shall carry out the duties of the Senior Lectureship under the direction of the Professor of Occupational Therapy or, in the event of a vacancy in the said Professorship, under the direction of such Head of Department as Údarás na hOllscoile shall deem appropriate.
6. The holder of the said Senior Lectureship in Speech and Language Therapy shall carry out the duties of the Senior Lectureship under the direction of the Professor of Speech and Language Therapy or, in the event of a vacancy in the said Professorship, under the direction of such Head of Department as Údarás na hOllscoile shall deem appropriate.

### CHAPTER III

#### THE ACADEMIC COUNCIL

1. Statute CCLIV, Chapter I, as amended by Statute CCLXIII, Chapter II, is hereby further amended by the addition of the following Paragraphs to Section 1 thereof:

“(xvii) The Director of the Centre for Excellence in Learning and Teaching.  
(xviii) The Education Officer of the Students’ Union.”

### CHAPTER IV

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.
2. This Statute shall come into operation on the twelfth day of December, Two Thousand and Two, and may be cited as Statute CCLXXIX, National University of Ireland, Galway, or Stat. CCLXXIX, Nat. Univ. of I., Galway.
