STATUTE CCVI

We, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

Given under the Common Seal of University College, Galway, this twenty-fourth day of October, One Thousand and Nine Hundred and Ninety.

SCHEDULE - STATUTE CCVI

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

1. There shall be established in the College, in the event of their institution by the Senate of the National University of Ireland, the following full-time Associate Professorships:

Associate Professorship (No. 2) of Physiology Associate Professorship (No. 4) of Chemistry

2. The annual stipend attaching to the foregoing Associate Professorships shall be the same as that attaching from time to time to the full-time Associate Professorships of the College.

3. The holder of Associate Professorship (No. 2) of Physiology shall carry out his duties under the direction of the Professor of Physiology.

4. The holder of Associate Professorship (No. 4) of Chemistry shall carry out his duties under the direction of the Professor of Chemistry. Notwithstanding that provision, the Governing Body shall have the right to assign, on the recommendation of the President, the direction of the said Associate Professorship to such Professor within the Department of Chemistry as it deems appropriate.

5. The foregoing Associate Professorships shall be pensionable offices in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI and CLXXXVII, University College, Galway.

6. The holder of each of the said Associate Professorships shall, subject to good conduct and the due fulfilment of his duties, continue in office until he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office be recommended to the Senate of the National University of Ireland by the Governing Body with the approval of the President and be sanctioned annually by the said Senate.

7. On the occurrence of a vacancy in the Lectureship in Physiology, the said Lectureship shall thereupon be abolished.

8. On the occurrence of a vacancy in the Lectureship (No. 8) in Chemistry, the said Lectureship shall thereupon be abolished.

CHAPTER II

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.

2. This Statute shall come into operation on the twenty-fourth day of October, One Thousand Nine Hundred and Ninety, and may be cited as Statute CCVI, University College, Galway, or Stat. CCVI, Univ. Coll., Galway.
