STATUTE CCXCIII

WE, Údarás na hOllscoile of National University of Ireland, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of National University of Ireland, Galway make the Statute contained in the Schedule hereto for the general government of the said University.

SCHEDULE - STATUTE CCXCIII

All previous Statutes of National University of Ireland, Galway shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

ST. ANGELA'S COLLEGE, SLIGO

1. Whereas an Agreement has been concluded between the University and St. Angela's College, Sligo, whereby St. Angela's College, Sligo shall become a College of National University of Ireland, Galway, while preserving the independent and separate legal status of the College and maintaining its ethos, and whereas the said College shall cease to be a Recognised College of the National University of Ireland on December 31, 2005, St. Angela's College, Sligo shall henceforth be a College of National University of Ireland, Galway in accordance with the terms of the said Agreement.
2. The foregoing provision shall be deemed to have come into effect on January 1, 2006.

CHAPTER II

ÚDARÁS NA hOLLSCOILE

1. Pursuant to the Agreement referred to in Section 1 of Chapter I of this Statute and in accordance with the provisions of Subsection 6 of Section 16 of Chapter II of the Universities Act, 1997, the President of St. Angela's College, Sligo shall be a member of Údarás na hOllscoile, with effect from January 1, 2006.

CHAPTER III

ACADEMIC COUNCIL

1. Pursuant to the Agreement referred to in Section 1 of Chapter I of this Statute, Statute CCLIV, Chapter I, as amended by Statute CCLXXIII, Chapter II, Statute CCLXXIX, Chapter III, and Statute CCLXXXVIII, Chapter I, is hereby further amended by the addition of the following Paragraph to Section 1 thereof:

“(xx) The President and the Registrar of St. Angela's College, Sligo and one other member of the Academic Council of the said College nominated by the Academic Council of the said College.”

CHAPTER IV
FACULTY MEMBERSHIP

1. Pursuant to the Agreement referred to in Section 1 of Chapter I of this Statute, and notwithstanding anything contained in any previous Statute of the University, and in particular in Chapter XI of Statute XVII, in Chapter I of Statute CXI, in Chapter I of Statute CCIII, in Chapter I of Statute CCLXIX, in Chapter II of Statute CCLXXXVIII and in Chapter I of Statute CCXC, each fulltime member of the academic staff of St. Angela's College, Sligo shall be a member of such Faculty of the University as may be decided from time to time by the Standing Committee of the Academic Council.

CHAPTER V

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.
2. This Statute shall be deemed to have come into operation on the first day of January, Two Thousand and Six, and may be cited as Statute CCXCIII, National University of Ireland, Galway, or Stat. CCXCIII, Nat. Univ. of I., Galway.
