#### STATUTE CCXCIV

7, Údarás na hOllscoile of National University of Ireland, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of National University of Ireland, Galway, make the Statute contained in the Schedule hereto for the general government of the said University.

#### Schedule - STATUTE CCXCIV

All previous Statutes of National University of Ireland, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

#### CHAPTER I

# ESTABLISHED PROFESSORSHIP OF CANCER THERAPEUTICS

 There is hereby established in the University the following Established Professorship:

### Established Professorship of Cancer Therapeutics.

- 2. The holder of the foregoing Established Professorship shall be required to be at the same time the holder in a permanent capacity of the office of Consultant Haematologist to be established in conjunction with the said Established Professorship by the Health Service Executive in the University College/ Merlin Park Regional Hospitals, Galway. In the event that the holder of the Established Professorship ceases to hold the said office of Consultant Haematologist, (s)he shall thereby be deemed to have resigned from the said Established Professorship.
- The holder of the said Established Professorship shall devote eight-elevenths of his/her time to the duties of the said Established Professorship and threeelevenths of his/her time to the duties of the foregoing office of Consultant Haematologist.
- 4. The annual stipend attaching to the said Established Professorship shall be eight-elevenths of the salary attaching from time to time to joint fulltime Academic Medical Consultant Professor appointments.
- 5. The holder of the said Established Professorship shall deliver clinical instruction to the students of the University at such hours and in such hospitals as the Academic Council may prescribe, subject to review by Údarás na hOllscoile.
- The said Established Professorship shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.
- 7. The holder of the said Established Professorship shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile.
- 8. The holder of the said Established Professorship shall carry out the duties of the Established Professorship under the direction of the Head of the Department of Medicine.

#### **CHAPTER II**

#### ESTABLISHED PROFESSORSHIP OF DIGITAL ENTERPRISE

1. There is hereby established in the University the following fulltime Established Professorship:

#### Established Professorship of Digital Enterprise.

- 2. The annual stipend attaching to the foregoing Established Professorship shall be the same as that attaching from time to time to the fulltime Established Professorships of the University.
- 3. The said Established Professorship shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.
- 4. The holder of the said Established Professorship shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile.
- 5. The holder of the said Established Professorship shall carry out the duties of the Established Professorship under the direction of the Head of the Digital Enterprise Research Institute.

#### CHAPTER III

#### PERSONAL PROFESSORSHIP OF HAEMATOLOGY

1. There is hereby established in the University the following Personal Professorship:

#### Personal Professorship of Haematology.

The holder of the foregoing Personal Professorship shall be required to be at the same time the holder in a permanent capacity of the office of Consultant Haematologist to be established in conjunction with the said Personal Professorship by the Health Service Executive in the University College/Merlin Park Regional Hospitals, Galway. In the event that the holder of the Personal Professorship ceases to hold the said office of Consultant Haematologist, (s)he shall thereby be deemed to have resigned from the said Personal Professorship.

- The holder of the said Personal Professorship shall devote three-elevenths of his/her time to the duties of the said Personal Professorship and eight-elevenths of his/her time to the duties of the foregoing office of Consultant Haematologist.
- 4. The annual stipend attaching to the said Personal Professorship shall be threeelevenths of the salary attaching from time to time to joint fulltime Academic Medical Consultant Associate Professor appointments.
- 5. The holder of the said Personal Professorship shall deliver clinical instruction to the students of the University at such hours and in such hospitals as the Academic Council may prescribe, subject to review by Údarás na hOllscoile.
- 6. The said Personal Professorship shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.
- 7. The holder of the said Personal Professorship shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile.
- The holder of the said Personal Professorship shall carry out the duties of the Personal Professorship under the direction of the Head of the Department of Medicine.

### **CHAPTER IV**

#### NEW PERSONAL PROFESSORSHIPS

1. There are hereby established in the University the following fulltime Personal Professorships:

Personal Professorship (No. 5) of Biochemistry Personal Professorship of Digital Enterprise.

- The annual stipend attaching to the foregoing Personal Professorships shall be the same as that attaching from time to time to the fulltime Personal Professorships of the University.
- The said Personal Professorships shall be pensionable offices in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.

- 4. The holder of each of the said Personal Professorships shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile.
- The holder of Personal Professorship (No. 5) of Biochemistry shall carry out the duties of the Personal Professorship under the direction of the Head of the Department of Biochemistry.
- The holder of the Personal Professorship of Digital Enterprise shall carry out the duties of the Personal Professorship under the direction of the Head of the Digital Enterprise Research Institute.

### CHAPTER V

## NEW SENIOR LECTURESHIPS

 There are hereby established in the University the following Senior Lectureships:

Senior Lectureship in Bacteriology Senior Lectureship (No. 10) in Surgery.

- 2. The holder of the Senior Lectureship in Bacteriology shall be required to be at the same time the holder in a permanent capacity of the office of Consultant Microbiologist to be established in conjunction with the said Senior Lectureship by the Health Service Executive in the University College/Merlin Park Regional Hospitals, Galway. In the event that the holder of the said Senior Lectureship ceases to hold the said office of Consultant Microbiologist, (s)he shall thereby be deemed to have resigned from the said Senior Lectureship.
- The holder of the Senior Lectureship in Bacteriology shall devote one-half of his/her time to the duties of the said Senior Lectureship and one-half of his/her time to the duties of the foregoing office of Consultant Microbiologist.
- The annual stipend attaching to the Senior Lectureship in Bacteriology shall be one-half of the salary attaching from time to time to joint fulltime Academic Medical Consultant Senior Lecturer appointments.
- 5. The holder of the Senior Lectureship (No. 10) in Surgery shall be required to be at the same time the holder in a permanent capacity of the office of Consultant Surgeon to be established in conjunction with the said Senior Lectureship by the Health Service Executive in the University College/Merlin Park Regional Hospitals, Galway. In the event that the holder of the said Senior Lectureship ceases to hold the said office of Consultant Surgeon, (s)he shall thereby be deemed to have resigned from the said Senior Lectureship.

- 6. The holder of the Senior Lectureship (No. 10) in Surgery shall devote twoelevenths of his/her time to the duties of the said Senior Lectureship and nineelevenths of his/her time to the duties of the foregoing office of Consultant Surgeon.
- 7. The annual stipend attaching to the Senior Lectureship (No. 10) in Surgery shall be two-elevenths of the salary attaching from time to time to joint fulltime Academic Medical Consultant Senior Lecturer appointments.
- 8. The holder of each of the foregoing Senior Lectureships shall deliver clinical instruction to the students of the University at such hours and in such hospitals as the Academic Council may prescribe, subject to review by Údarás na hOllscoile.
- 9. Each of the said Senior Lectureships shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.
- 10. The holder of each of the said Senior Lectureships shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile.
- The holder of the Senior Lectureship in Bacteriology shall carry out the duties
  of the Senior Lectureship under the direction of the Head of the Department of
  Bacteriology.
- 12. The holder of Senior Lectureship (No. 10) in Surgery shall carry out the duties of the Senior Lectureship under the direction of the Head of the Department of Surgery.

#### CHAPTER VI

- 1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.
- 2. This Statute shall come into operation on the eleventh day of May, Two Thousand and Six, and may be cited as Statute CCXCIV, National University of Ireland, Galway, or Stat. CCXCIV, Nat. Univ. of I., Galway.
