STATUTE CCXCIX

WE, Údarás na hOllscoile of National University of Ireland, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of National University of Ireland, Galway, make the Statute contained in the Schedule hereto for the general government of the said University.

Schedule - STATUTE CCXCIX

All previous Statutes of National University of Ireland, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

NEW FULLTIME ESTABLISHED PROFESSORSHIPS

1. There are hereby established in the University the following fulltime Established Professorships:

Established Professorship of Health Technology Assessment
Established Professorship of Marine Environment
Moore Institute Established Professorship of the Technologies of Text and
Image Production.

- The annual stipend attaching to each of the foregoing Established Professorships shall be the same as that attaching from time to time to the fulltime Established Professorships of the University.
- 3. Each of the said Established Professorships shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.
- 4. The holder of each of the said Established Professorships shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile.
- The holder of each of the said Established Professorships shall carry out the
 duties of the Established Professorship under the direction of such Head of
 Department as Údarás na hOllscoile shall from time to time deem appropriate.

CHAPTER II

NEW PART-TIME ESTABLISHED PROFESSORSHIPS

1. There are hereby established in the University the following part-time Established Professorships:

Established Professorship of Primary Care Research and Development Established Professorship of Medical and Health Care Education Established Professorship of Radiation Oncology. 2. The holder of each of the foregoing Established Professorships shall be required to be at the same time the holder in a permanent capacity of an office of Consultant, as indicated below, to be established in conjunction with the said Established Professorship by the Health Service Executive in the University College/Merlin Park Regional Hospitals, Galway. In the event that the holder of the said Established Professorship ceases to hold the said office of Consultant, (s)he shall thereby be deemed to have resigned from the said Established Professorship.

Established Professorship of Primary Care Research and Development: Consultant in General Practice.

Established Professorship of Medical and Health Care Education: Consultant in General Practice or in such other specialism as may be decided.

Established Professorship of Radiation Oncology: Consultant Radiation Oncologist.

- 3. The holder of the Established Professorship of Primary Care Research and Development and the holder of the Established Professorship of Medical and Health Care Education shall devote eight-elevenths of his/her time to the duties of the said Established Professorship and three-elevenths of his/her time to the duties of the foregoing office of Consultant.
- 4. The annual stipend attaching to the Established Professorship of Primary Care Research and Development and the Established Professorship of Medical and Health Care Education shall be eight-elevenths of the salary attaching from time to time to joint fulltime Academic Medical Consultant Professor appointments.
- 5. The holder of the Established Professorship of Radiation Oncology, shall devote two-elevenths of his/her time to the duties of the said Established Professorship and nine-elevenths of his/her time to the duties of the foregoing office of Consultant.
- 6. The annual stipend attaching to the Established Professorship of Radiation Oncology shall be two-elevenths of the salary attaching from time to joint fulltime Academic Medical Consultant Professor appointments.
- 7. The holder of each of the said Established Professorships shall deliver clinical instruction to the students of the University at such hours and in such hospitals as the Academic Council may prescribe, subject to review by Údarás na hOllscoile.
- 8. Each of the said Established Professorships shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.

- 9. The holder of each of the said Established Professorships shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile.
- 10. The holder of each of the said Established Professorships shall carry out the duties of the Established Professorship under the direction of such Head of the Department as Údarás na hOllscoile shall from time to time deem appropriate.

CHAPTER III

NEW PERSONAL PROFESSORSHIPS

1. There are hereby established in the University the following Personal Professorships:

Moore Institute Personal Professorship of the Technologies of Text and Image Production
Personal Professorship of Medical Oncology.

- 2. The annual stipend attaching to the said Moore Institute Personal Professorship of the Technologies of Text and Image Production shall be the same as that attaching from time to time to the fulltime Personal Professorships of the University.
- 3. The holder of the Personal Professorship of Medical Oncology shall be required to be at the same time the holder in a permanent capacity of the office of Consultant Medical Oncologist to be established in conjunction with the said Personal Professorship by the Health Service Executive in the University College/Merlin Park Regional Hospitals, Galway. In the event that the holder of the Personal Professorship ceases to hold the said office of Consultant Medical Oncologist, (s)he shall thereby be deemed to have resigned from the said Personal Professorship.
- 4. The holder of the said Personal Professorship of Medical Oncology shall devote two-elevenths of his/her time to the duties of the said Personal Professorship and nine-elevenths of his/her time to the duties of the foregoing office of Consultant Medical Oncologist.
- 5. The annual stipend attaching to the Personal Professorship of Medical Oncology shall be two-elevenths of the salary attaching from time to time to joint fulltime Academic Medical Consultant Associate Professor appointments.

- 6. The holder of the said Personal Professorship of Medical Oncology shall deliver clinical instruction to the students of the University at such hours and in such hospitals as the Academic Council may prescribe, subject to review by Údarás na hOllscoile.
- 7. Each of the said Personal Professorships shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.
- 8. The holder of each of the said Personal Professorships shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile.
- 9. The holder of each of the said Personal Professorships shall carry out the duties of the Personal Professorship under the direction of such Head of the Department as Údarás na hOllscoile shall from time to time deem appropriate.

CHAPTER IV

ESTABLISHED PROFESSORSHIP OF IMMUNOLOGY

1. The Established Professorship of Immunology shall henceforth be known as the Established Professorship of Transplant Biology.

CHAPTER V

ESTABLISHED PROFESSORSHIP OF CANCER THERAPEUTICS

- 1. The provisions of Chapter I of Statute CCXCIV are hereby amended as follows:
- 2. The holder of the Established Professorship of Cancer Therapeutics shall devote four-elevenths of his/her time to the duties of the said Established Professorship within the University.
- 3. The holder of the said Established Professorship shall devote four-elevenths of his/her time to the provision of academic services to Trinity College, Dublin and clinical services to St. James's Hospital, Dublin, in accordance with the terms of a Service Level Agreement between the University, Trinity College, Dublin, the Health Service Executive, and St. James's Hospital, Dublin.

4. Four-elevenths of the annual stipend attaching to the said Established Professorship shall be payable by the University, and four-elevenths of the said stipend shall be payable by Trinity College, Dublin and St. James's Hospital, Dublin, in accordance with the terms of the foregoing Service Level Agreement.

CHAPTER VI

NEW SENIOR LECTURESHIPS

1. There are hereby established in the University the following fulltime Senior Lectureships:

Senior Lectureship (No. 3) in Nursing Senior Lectureship (No. 4) in Nursing Senior Lectureship (No. 7) in Political Science and Sociology Senior Lectureship (No. 2) in Law.

- The annual stipend attaching to each of the foregoing Senior Lectureships shall
 be the same as that attaching from time to time to the fulltime Senior
 Lectureships of the University.
- 3. Each of the said Senior Lectureships shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII, CCVII and CCXXVI, National University of Ireland, Galway.
- 4. The holder of each of the said Senior Lectureships shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office be recommended to Údarás na hOllscoile by the President and be sanctioned annually by Údarás na hOllscoile.
- The holder of each of the said Senior Lectureships shall carry out the duties of the Senior Lectureship under the direction of such Head of Department as Údarás na hOllscoile shall from time to time deem appropriate.

CHAPTER VII

SENIOR LECTURESHIP IN WOMEN'S STUDIES

1. The Senior Lectureship in Women's Studies shall henceforth be known as the Senior Lectureship in Women's Studies (within Political Science and Sociology).

CHAPTER VIII

- 1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.
- 2. This Statute shall come into operation on the twentieth day of April, Two Thousand and Seven, and may be cited as Statute CCXCIX, National University of Ireland, Galway, or Stat. CCXCIX, Nat. Univ. of I., Galway.
