STATUTE CCXC

WE, Údarás na hOllscoile of National University of Ireland, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of National University of Ireland, Galway, make the Statute contained in the Schedule hereto for the general government of the said University.

Schedule - STATUTE CCXC

All previous Statutes of National University of Ireland, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

FACULTY MEMBERSHIP

1. Notwithstanding anything contained in any previous Statute of the University, and in particular in Chapter XI of Statute XVII, in Chapter I of Statute CXI, in Chapter I of Statute CCIII, in Chapter I of Statute CCLXIX, and in Chapter II of Statute CCLXXXVIII, the members of a Faculty shall include the Education Officer of the Students' Union, one registered undergraduate student elected annually by and from among the undergraduate class representatives of the said Faculty and one registered postgraduate student elected annually by and from among the postgraduate class representatives of the said Faculty, provided that the aforesaid members of the Faculty shall not be entitled to be present or to vote during consideration by the Faculty of academic appointments or of matters which relate to specific students, and provided further that each of the aforesaid members of Faculty shall not be eligible for election as Dean of the said Faculty and shall cease to be a member of the said Faculty when (s)he ceases to be a registered undergraduate student or postgraduate student, as the case may be, of the said Faculty.

CHAPTER II

SENIOR LECTURESHIP IN OTORHINOLARYNGOLOGY

1. The Senior Lectureship in Otorhinolaryngology shall henceforth be known the Senior Lectureship in Otolaryngology.

CHAPTER III

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.
2. This Statute shall come into operation on the ninth day of December, Two Thousand and Four, and may be cited as Statute CCXC, National University of Ireland, Galway, or Stat. CCXC, Nat. Univ. of I., Galway.
