**STATUTE CCXIV**

We, the Governing Body of University College, Galway, under and virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

Given under the Common Seal of University College, Galway, this twenty-third day of October, One Thousand Nine Hundred and Ninety-one.

**SCHEDULE-STATUTE CCXIV**

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

## CHAPTER I

1. Notwithstanding anything contained in any previous Statute of the College, the stipend attaching to the Office of President shall, as from the 1st day of April, 1990, be £52,767.
2. For the purpose of calculating the pension and gratuity respectively payable on the retirement and on the death or retirement of the President, the annual stipend deemed to be payable at date of retirement or at date of death shall be £56,001, as from the 1st day of April, 1990.
3. As from the 1st day of April, 1990, the annual stipend attached to the Offices of Secretary-Bursar, Academic Secretary, Librarian, full-time Professorships, part-time Professorships, the Associate Professorship of Zoology until the existing holder of the said Associate Professorship shall cease to hold the said Office, part-time Associate Professorships and part-time Lectureships shall be increased by 4.1%.

## CHAPTER II

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
2. This Statute shall come into operation on the twenty-third day of October, One Thousand Nine Hundred and Ninety-one and may be cited as Statute CCXIV, University College, Galway, or Stat. CCXIV, Univ. Coll., Galway.
