**STATUTE CCXLVI**

We, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

Given under the Common Seal of University College, Galway, this twenty-third day of April , One Thousand Nine Hundred and Ninety-seven.

**SCHEDULE - STATUTE CCXLVI**

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.


## CHAPTER I

1. The Associate Professorship of Botany shall henceforth be known as the Associate Professorship (No. 3) of Experimental Physics.
2. The Associate Professorship of Physiology shall henceforth be known as the Associate Professorship (No. 4) of History.
3. The Associate Professorship (No. 2) of Microbiology shall henceforth be known as the Associate Professorship (No. 6) of Chemistry.
4. The holder of the Associate Professorship (No. 3) of Experimental Physics shall carry out his duties under the direction of the Head of the Department of Experimental Physics.
5. The holder of the Associate Professorship (No. 4) of History shall carry out his duties under the direction of the Professor of History.
6. The holder of the Associate Professorship (No. 6) of Chemistry shall carry out his duties under the direction of the Professor of Chemistry. Notwithstanding that provision, the Governing Body shall have the right to assign, on the recommendation of the President, the direction of the said Associate Professorship to such Professor within the Department of Chemistry as it deems appropriate.
7. On the occurrence of a vacancy in the Lectureship (No. 2) in Applied Physics and Electronics, the said Lectureship shall thereupon be abolished.
8. On the occurrence of a vacancy in the Lectureship in History, the said Lectureship shall thereupon be abolished.
9. On the occurrence of a vacancy in the Lectureship (No. 5) in Chemistry, the said Lectureship shall thereupon be abolished.

## CHAPTER II

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
2. This Statute shall come into operation on the twenty-third day of April, One Thousand Nine Hundred and Ninety-seven, and may be cited as Statute CCXLVI, University College, Galway, or Stat. CCXLVI, Univ. Coll., Galway.
