STATUTE CCXVI

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

SCHEDULE - STATUTE CCXVI

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

- 1. There are hereby established in the College two Offices of Vice-President.
- (a) The Vice-Presidents shall be appointed by the Governing Body, on the recommendation of the President. The President shall recommend for appointment to one of the said Offices one of three persons recommended by the Academic Council.
 - (b) The provisions of Statute XXIII, Section 2, as amended by Section 2 of Statute XXXII, Section 3, as amended by Section 3 of Statute XXXII, Section 5, Section 6 and Section 8 in regard to competency to discharge the duties of the Office through the medium of the Irish language shall apply to the appointment of the Vice-Presidents. The Academic Council shall recommend, for recommendation by the President for appointment by the Governing Body as Vice-President, a candidate who possesses the Irish language qualification, provided a person so qualified and also suitable in all other respects is to be found among the candidates for the said Office.
- 3. The Vice-Presidents shall hold Office for three years and may be reappointed for a second three-year term. No person shall serve as Vice-President for an aggregate period of more than six years, provided that in the event of a person's being appointed to fill a casual vacancy in an Office of Vice-President no account shall be taken of the remainder of his/her predecessor's term.
- 4. The Office of Vice-President shall be a part-time, non-pensionable Office.
- 5. The stipend attaching to the Office of Vice-President shall be £4,000.
- The duties of each Vice-President shall be determined by the Governing Body, by Regulation, following recommendation of the President. Each Vice-President shall carry out his/her duties under the direction of the President and shall, when required, attend meetings of the Governing Body.

CHAPTER II

- Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
- This Statute shall come into operation on the twenty-second day of January, One Thousand Nine Hundred and Ninety-two, and may be cited as Statute CCXVI, University College, Galway, or Stat. CCXVI, Univ. Coll., Galway.
