STATUTE CCXXV

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

Given under the Common Seal of University College, Galway, this twenty-fifth day of November, One Thousand Nine Hundred and Ninety-two.

SCHEDULE - STATUTE CCXXV

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

1. There shall be established in the College, in the event of its institution by the Senate of the National University of Ireland, the following fulltime Lectureship:

Lectureship in Health Promotion.

2. The annual stipend attaching to the foregoing Lectureship shall be the same as that attaching from time to time to the fulltime Lectureships of the College.
3. The holder of the said Lectureship shall carry out the duties of the Lectureship under the direction of the Professor of Health Promotion.
4. The said Lectureship shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXXVII and CCVII, University College, Galway.
5. The holder of the said Lectureship shall, in accordance with the provisions of Statute CXCIV, subject to good conduct and the due fulfilment of his/her duties and to having served a probationary period of two years in the said office to the satisfaction of the Governing Body of the College and of the Senate of the University, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years : **PROVIDED** that such further continuance in office be recommended to the Senate of the National University of Ireland by the Governing Body with the approval of the President and be sanctioned annually by the said Senate.

CHAPTER II

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
2. This Statute shall come into operation on the twenty-fifth day of November, One Thousand Nine Hundred and Ninety-two, and may be cited as Statute CCXXV, University College, Galway, or Stat. CCXXV, Univ. Coll., Galway.
