STATUTE CCXX

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

Given under the Common Seal of University College, Galway, this twenty-second day of April, One Thousand Nine Hundred and Ninety-two.

SCHEDULE - STATUTE CCXX

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

1. There shall be established in the College, in the event of its institution by the Senate of the National University of Ireland, the following fulltime Professorship:

PROFESSORSHIP OF GENERAL PRACTICE.

- 2. The annual stipend attaching to the foregoing Professorship shall be the same as that attaching from time to time to the fulltime Professorships of the College; the said stipend may be enhanced or reduced by resolution of the Governing Body following determination of the arrangement referred to in Section 6 of this Chapter.
- 3. The holder of the said Professorship shall, subject to good conduct and the due fulfilment of his/her duties, continue in office until (s)he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years:

 PROVIDED that such further continuance in office be recommended to the Senate of the National University of Ireland by the Governing Body with the approval of the President and be sanctioned annually by the said Senate.
- 4. The said Professorship shall be a pensionable office in accordance with the provisions of Statutes CLXI, CLXV, CLXXXVI, CLXXVII and CCVII, University College, Galway.
- 5. The holder of the said Professorship shall give clinical instruction to the students of the College at such hours and at such locations as the Academic Council may prescribe, subject to review by the Governing Body.
- 6. The holder of the said Professorship shall, in addition, discharge such professional duties as are appropriate to the office in accordance with an arrangement determined by the Governing Body.
- 7. The holder of the said Professorship shall be precluded from engaging in private practice or consultancies in any form or retaining any fees which may be received by him/her in connection with his/her work except in so far as may be provided under the arrangement referred to in Section 6 of this Chapter.

CHAPTER II

- Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
- 2. This Statute shall come into operation on the twenty-second day of April, One Thousand Nine Hundred and Ninety-two, and may be cited as Statute CCXX, University College, Galway, or Stat. CCXX, Univ. Coll. Galway.
