STATUTE CIV

WE, the Governing Body of University College, Galway under and by virtue of the powers in that behalf conferred on us by the above Acts DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

SCHEDULE—STATUTE CIV

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions, and modifications hereinafter set forth.

CHAPTER I

STIPENDS AND ALLOWANCES ATTACHED TO THE
OFFICE OF PRESIDENT

1. Notwithstanding anything contained in any previous Statute of the College, the stipend and allowances attached to the office of President shall be the stipend and allowances at the following annual rates:
 - (a) From the first day of June 1974 to the thirtieth day of November 1974.
The Annual Stipend of the President shall be £10,266. In addition, he shall be entitled to residence, fuel and light as heretofore, valued for pension purposes at £1,477 p.a., and to a non-pensionable allowance of £1,477 p.a. in respect of the expenses of his office. The College shall be responsible for payment of the rates on the President's house.
 - (b) From the first day of December 1974 to twenty-eighth day of February 1975.
The Annual Stipend of the President shall be £10,818. In addition, he shall be entitled to residence, fuel and light

as heretofore, valued for pension purposes at £1,551 p.a. and to a non-pensionable allowance of £1,551 p.a. in respect of the expenses of his office. The College shall be responsible for payment of the rates on the President's house.

- (c) From the first day of March 1975 to the thirty-first day of May 1975.
The Annual Stipend of the President shall be £11,900. In addition, he shall be entitled to residence, fuel and light as heretofore, valued for pension purposes at £1,706 p.a., and to a non-pensionable allowance of £1,706 p.a., in respect of the expenses of his office. The College shall be responsible for payment of the rates on the President's house.
- (d) From the first day of June 1975 to the thirty-first day of August 1975.
The Annual Stipend of the President shall be £12,962. In addition, he shall be entitled to residence, fuel and light as heretofore, valued for pension purposes at £1,856 p.a., and to a non-pensionable allowance of £1,856 p.a., in respect of the expenses of his office. The College shall be responsible for payment of the rates on the President's house.

CHAPTER II

STIPENDS ATTACHED TO STATUTORY OFFICES AND FULL-TIME PROFESSORSHIPS

Notwithstanding anything contained in any previous Statute of the College, the stipends (both as to stipends on appointment and as to maxima) attached to the Offices of Secretary/Bursar, Academic Secretary, Librarian, and full-time Professorships shall be at the following annual rates:---

- (a) From the first day of June 1974 to the thirtieth day of November 1974.
£5,629 on appointment, increasing to a maximum of £6,736 in accordance with Table A of this Statute, subject to the provisions where applicable of Chapter II of Statute LIV of University College, Galway.
- (b) From the first day of December 1974 to the twenty-eighth day of February 1975.
£5,955 on appointment, increasing to a maximum of £7,117 in accordance with Table A of this Statute, subject to the provisions where applicable of Chapter II of Statute LIV of University College, Galway.
- (c) From the first day of March 1975 to the thirty-first day of May 1975.
£6,551 on appointment, increasing to a maximum of £7,829 in accordance with Table A of this Statute, subject to the provisions where applicable of Chapter II of Statute LIV of University College, Galway.
- (d) From the first day of June 1975 to the thirty-first day of August 1975.

£7,145 on appointment, increasing to a maximum of £8,536 in accordance with Table A of this Statute, subject to the provisions where applicable of Chapter II of Statute LIV of University College, Galway.

CHAPTER III

STIPENDS ATTACHED TO FULL-TIME STATUTORY ASSOCIATE PROFESSORSHIPS AND ASSOCIATE SECRETARYSHIPS

Notwithstanding anything contained in any previous Statute of the College, the stipends attached to the offices of statutory full-time Associate Professors and Associate Secretaries shall be at the following annual rates:

- (a) From the first day of June 1974 to the thirtieth day of November 1974.

- (b) From the first day of December 1974 to the twenty-eighth day of February 1975.

- (c) From the first day of March 1975 to the thirty-first day of May 1975.

CHAPTER IV

STIPENDS ATTACHED TO FULL-TIME STATUTORY LECTURESHIPS

Notwithstanding anything contained in any previous Statute of the College, the stipends (both as to stipends on appointment and as to maxima) attached to full-time Statutory Lectureships shall be at the following annual rates:—

- (a) From the first day of June 1974 to the thirtieth day of November 1974.
£4,074 on appointment, increasing to a maximum of £5,587 in accordance with Table A of this Statute, subject to the provisions where applicable of Chapter II of Statute LIV of University College, Galway.
- (b) From the first day of December 1974 to the twenty-eighth day of February 1975.
£4,325 on appointment, increasing to a maximum of £5,910 in accordance with Table A of this Statute, subject to the provisions where applicable of Chapter II of Statute LIV of University College, Galway.

- (c) From the first day of March 1975 to the thirty-first day of May 1975.
£4,758 on appointment, increasing to maximum of £6,501 in accordance with Table A of this Statute, subject to the provisions where applicable of Chapter II of Statute LIV of University College, Galway.
- (d) From the first day of June 1975 to the thirty-first day of August 1975.
£5,196 on appointment, increasing to a maximum of £7,090 in accordance with Table A of this Statute, subject to the provisions where applicable of Chapter II of Statute LIV of University College, Galway.

CHAPTER V

CHAPTER VI

MARRIAGE AND CHILDREN'S ALLOWANCES AS FROM 1st JUNE, 1975

1. Section I of Chapter IV of Statute XCVII of University College, Galway is hereby amended: (a) by the substitution of the figure £157 for the figure £132 mentioned therein; (b) by the substitution of the figure £94 for the figure £81 mentioned therein; (c) by the substitution of the figure £47 for the figure £40.50 mentioned therein; (d) by the substitution of the figure £35 for the figure £30 mentioned therein.
2. This Chapter shall be deemed to have come into operation on the thirty-first day of May 1975, and the increased allowances set out in Section I hereof shall be payable as and from the first day of June 1975, subject to the provision set forth in Chapter VIII of this Statute.

CHAPTER VII

PENSIONS AND GRATUITIES

1. For the purpose of calculating the pension and gratuity respectively payable on the retirement and on the death or retirement of the President, the annual stipend deemed to be payable at date of retirement or at date of death shall be £11,743 as and from the first day of June 1974, £12,369 as and from the first day of December 1974, £13,606 as and from the first day of March 1975, and £14,818 as and from the first day of June 1975, subject to the provisions of Chapter VIII of this Statute.

For the purpose of calculating the pension and gratuity respectively payable on the retirement and on the death or retirement of the Lady Superintendent the annual stipend payable to her at date of retirement or at date of death, shall be (deemed to be) £4,203 as and from the first day of June 1974, £4,460 as and from the first day of December 1974, £4,906 as and from the first day of March 1975, and £5,356 as and from the first day of June 1975, subject to the provisions of Chapter VIII of this Statute.
2. Instead of the sums now being paid annually into the Statutory Pensionable Officers' Pension Fund and into Pension Fund No. 2, there shall henceforth be paid and transferred to the said funds out of the annual Income granted by the Oireachtas for the general purposes of the College or out of any other monies of the College applicable thereto such sums as an Actuary shall certify to be necessary for providing Pensions and Gratuities.

3. On the coming into operation of this Statute, former holders of Pensionable Professorships, Pensionable Lectureships or Pensionable Offices, or the Widows of such persons, shall be entitled to have their current pensions calculated and paid in the manner and subject to the Conditions prescribed by Statute LI of University College, Galway, subject to the provisions of Statute LXXII, Statute LXXX, and (where applicable) of Statute LXVI and of Chapter I of Statute LXXIV.

CHAPTER VIII

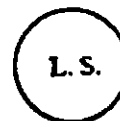
STIPENDS AND ALLOWANCES ATTACHED TO STATUTORY OFFICES PROFESSORSHIPS AND LECTURESHPIS FROM 1ST SEPTEMBER 1975

1. The stipends and allowances attaching to all the foregoing offices shall be increased from the first day of September 1975 by 4%, or the figure for the Consumer Price Index percentage in the index period mid-February 1975 to mid-May 1975, if greater, the amount of the phase not to exceed 5%.
2. The stipends and allowances attaching to all the foregoing offices shall be increased from the first day of December 1975 by the appropriate portion of the Fourteenth Round, Phase II, increase.
3. The stipends and allowances attaching to all the foregoing offices shall be increased from the first day of March 1976 by the figure for the percentage increase in the Consumer Price Index in the index period mid-August 1975 to mid-November 1975.

CHAPTER IX

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
2. This Statute shall come into operation on the twenty-fourth day of October, One Thousand Nine Hundred and Seventy-five and may be cited as Statute CIV of University College, Galway, or Stat. CIV Univ. Coll. Galway.
