STATUTE CLIII

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by above Acts, DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

Given under the Common Seal of University College, Galway, this twenty-seventh day of May, One Thousand Nine Hundred and Eighty-one.

SCHEDULE - STATUTE CLIII

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

1. The Lectureship in Civil Engineering instituted by Statute XXXI shall henceforth be known as Lectureship (No. 1) in Civil Engineering.
2. Section 5 of Statute XXXI is hereby revoked.
3. The particular speciality, if any, in which the holders of Lectureship (No. 1) in Civil Engineering, Lectureship (No. 2) in Civil Engineering, and Lectureship (No. 4) in Civil Engineering, shall be required to be particularly qualified shall be specified, on the recommendation of the Academic Council, by simple resolution of the Governing Body.

4. On the occurrence of a vacancy in Lectureship (No. 3) in Civil Engineering or Lectureship (No. 7) in Civil Engineering or Lectureship (No. 8) in Civil Engineering, the particular speciality, if any, in which the holder of the said Lectureship shall be required to be particularly qualified shall be specified, on the recommendation of the Academic Council, by simple resolution of the Governing Body

CHAPTER II

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
2. This Statute shall come into operation on the twenty-seventh day of May, One Thousand Nine Hundred and Eighty-one and may be cited as Statute CLIII University College, Galway, or Stat. CLIII Univ. Coll., Galway
