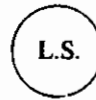

STATUTE CLXIX

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by above Acts, DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

Given under the Common Seal of University College, Galway, this nineteenth day of April, One Thousand Nine Hundred and Eighty-four.

SCHEDULE - STATUTE CLXIX

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

1. There shall be established in the College, in the event of its institution by the Senate of the National University of Ireland, the following fulltime Professorship:

ASSOCIATE PROFESSORSHIP OF STATISTICS (within the  
Dept. of Mathematics)

2. The annual stipend attaching to the foregoing Associate Professorship shall be the same as that attaching from time to time to the fulltime Associate Professorships of the College.

3. The holder of the foregoing Associate Professorship shall carry out his duties under the direction of the Professor of Mathematics. If and so long as the vacancy in the Professorship of Statistics (within the

Department of Mathematics) is filled, the holder of the foregoing Associate Professorship shall carry out his duties under the direction of the Professor of Statistics (within the Department of Mathematics).

4. The holder of the foregoing Associate Professorship shall, subject to good conduct and the due fulfilment of his duties, continue in office until he shall have attained the age of sixty-five years and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office be recommended to the Senate of the National University of Ireland by the Governing Body with the approval of the President and be sanctioned annually by the said Senate.

5. The foregoing Associate Professorship shall be a pensionable office in accordance with the provisions of Statute CLXI and Statute CLSV, University College, Galway.

## CHAPTER II

1. There shall be established in the College, in the event of their institution by the Senate of the National University of Ireland, the following fulltime Lectureships:

Lectureship (No. 4) in History

Lectureship (No. 2) in Pharmacology

2. The annual stipend attaching to the foregoing Lectureships shall be the same as that attaching from time to time to the fulltime Lectureships of the College.

3. The holder of Lectureship (No. 4) in History shall carry out his duties under the direction of the Professor of History.

4. The holder of Lectureship (No. 2) in Pharmacology shall carry out his duties under the direction of the Professor of Pharmacology (within the Department of Experimental Medicine and Practical Pharmacology).

5. The holder of each of the said Lectureships shall, subject to good conduct and the due fulfilment of his duties, hold office for seven years, after which he shall be eligible for reappointment. If reappointed, he shall, subject to good conduct and the due fulfilment of his duties, continue in office until he shall have attained the age of sixty-five years, and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office be recommended to the Senate of the National University of Ireland by the Governing Body with the approval of the President and be sanctioned annually by the said Senate.

6. The foregoing Lectureships shall be pensionable office in accordance with the provisions of Statute CLXI and Statute CLSV, University College, Galway.

CHAPTER III

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.

2. This Statute shall come into operation on the nineteenth day of April, One Thousand Nine Hundred and Eighty-four and may be cited as Statute CLXIX, University College, Galway or Stat. CLXIX, Univ. Coll., Galway.
