STATUTE CLXVI

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

SCHEDULE – STATUTE CLXVI

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

1. Notwithstanding anything contained in any previous Statute of the College, the stipend attached to the Office of President shall be £23,381 as from the 26th day of June, 1980, £25,303 as from the 1st day of October, 1980, and £27,075 as from the 1st day of June, 1981
2. Notwithstanding anything contained in any previous Statute of the College, on the coming into operation of this Statute the President shall cease to be entitled to an allowance in respect of the expenses of his Office. The President shall be reimbursed in a manner to be determined by the Governing Body any costs incurred by him in discharging the duties of his Office.

CHAPTER II

1. Notwithstanding anything contained in any previous Statute of the College, the stipends attached to the Offices of President, Librarian, fulltime Professorships, fulltime Associate Professorships, Associate Secretaryships and fulltime Lectureships shall as from the 1st day of December, 1981 be increased by 2% or £208.80 per annum, whichever is the greater.

2. As from the 1st day of March, 1982 the stipends attached to the Offices mentioned in Section 1 of this Chapter shall be increased by 6%.
3. As from the 1st day of January, 1983 the stipends attached to the Offices mentioned in Section 1 of this Chapter shall be increased by 5%.

### CHAPTER III

1. Notwithstanding anything contained in any previous Statute of the College, the annual stipend attached to each part-time Professorship, each part-time Associate Professorship and each part-time Lectureship shall as from the 1st day of December, 1981, as from the 1st day of March 1982 and as from the 1st day of January 1983 respectively, be increased as set out in respect to each post in Table A to this Chapter.

#### CHAPTER IV

1. Statute CLXIII, Chapter I, Section 1 is hereby amended by the substitution of the words "As from 1 January 1983" for the words "As from 1 October 1982" therein.
2. The persons entitled to the stipends mentioned in Statute CLXIII, Chapter I, Section 1 and in Chapter II, Section 1 and Chapter III Section 1 of this Statute, respectively, shall in addition be paid on or after the 1st day of February, 1983 a sum equivalent to 50% of the additional sum that would have been paid had the stipends payable as from the 1st day of January, 1983 applied as from the 1st day of October, 1982; the remaining 50% of that additional sum shall be payable on or after the 1st day of June, 1983.
3. The foregoing increases shall be subject to and calculated in accordance with the provisions of the Agreement on Public Service Pay between the Public Services Committee of the Irish Congress of Trade Unions and the Minister for the Public Service, as amended.
4. The Governing Body shall have power to round to the nearest pound the amounts of all stipends in which an increase is provided in this Statute.

#### CHAPTER V

1. For the purpose of calculating the pension and gratuity respectively payable on the retirement and on the death or retirement of the President, the annual stipend deemed to be payable at date of retirement or at date of death shall be £26,215 as from the 26th day of June, 1980, £28,364 as from the 1st day of October, 1980, £30,350 as from the 1st day of June, 1981, £30,958 as from the 1st day of December, 1981, £32,815 as from the 1st day of March, 1982, and £34,456 as from the 1st day of January, 1983

CHAPTER VI

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
2. This Statute shall come into operation on the first day of December, One Thousand Nine Hundred and Eighty-two and may be cited as Statute CLXVI, University College, Galway, or Stat. CLXVI, Univ. Coll., Galway.
