STATUTE CLXXVIII

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

SCHEDULE — STATUTE CLXXVIII

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

ELECTION BY THE GRADUATES OF MEMBERS OF THE
GOVERNING BODY

1. Statute LXVIII, Chapter II is hereby amended as follows:
 - a) By the substitution in Section 1, Subsection (a) of the words "at least four months" for the words "at least three months".
 - b) By the substitution in Section 2, Subsection (a) of the words "at least fifty days" for the words "at least twenty-eight days".
2. Statute XVII, Chapter VI, Section 14, as amended by Statute LXVIII, Section 2, Subsection (a), is hereby further amended by the addition of the words "which shall be accompanied by the written consent of the candidate nominated" after the words "a Nomination Paper signed by two Members of the elective body".

3. Statute XXI, Chapter II is hereby amended as follows:
 - a) By the substitution of the following Section for Section 15:

“If a candidate who is nominated at an election by the Academic Council is not a Professor of the College, or if a candidate who is nominated at an election by the Graduates of the University who are members of the College is not one of those Graduates, the nomination of such candidate shall be invalid and null”.
 - b) By the addition in Section 31 of the words “or of his not having received a Voting Paper” after the words “to the Registrar”.
4. Statute XXXV, Chapter 3 is hereby amended as follows:
 - a) By the substitution in Section 1 of the words “not less than twenty-eight days” for the words “not less than 10 days”.
 - b) By the substitution in Sections 2 and 3 of the words “the printed paper of instructions” for the words “the Voting Paper”.

CHAPTER II

THE LECTURESHIP IN OTORHINOLARYNGOLOGY — DUTIES

1. The holder of the Lectureship in Otorhinolaryngology shall carry out the duties of the Lectureship under the direction of the Professor of Surgery.

CHAPTER III

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
2. This Statute shall come into operation on the first day of March, One Thousand Nine Hundred and Eighty-five, and may be cited as Statute CLXXVIII, University College, Galway, or Stat. CLXXVIII, Univ. Coll., Galway.
