STATUTE CLXXX

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by above Acts, DO, by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

SCHEDULE — STATUTE CLXXX

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

1. There shall be established in the College, in the event of its institution by the Senate of the National University of Ireland, the following part-time Professorship:

ASSOCIATE PROFESSORSHIP OF PATHOLOGY.

- 2. The annual stipend attaching to the foregoing Associate Professorship shall be £6,000.
- 3. The holder of the foregoing Associate Professorship shall carry out his duties under the direction of the Professor of Pathology.

- 4. The holder of the foregoing Associate Professorship shall, subject to good conduct and the due fulfilment of his duties, continue in office until he shall have attained the age of sixty-five years and may thereafter be continued in office for five further years: PROVIDED that such further continuance in office be recommended to the Senate of the National University of Ireland by the Governing Body with the approval of the President and be sanctioned annually by the said Senate.
- The foregoing Associate Professorship shall be a pensionable office in accordance with the provisions of Statute CLXI and Statute CLXV, University College, Galway.

CHAPTER II

- Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
- This Statute shall come into operation on the sixth day of December, One Thousand Nine Hundred and Eighty-five and may be cited as Statute CLXXX, University College, Galway, or Stat. CLXXX, Univ. Coll., Galway.
