STATUTE CVII

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

SCHEDULE—STATUTE CVII

All previous Statutes of University College, Galway, and particularly Statute LXIX (specifically Chapter I, Section I and Chapter II, Section I, Sub-section (m) thereof), shall be read and construed with the alterations, additions and modifications herein-after set forth.

CHAPTER I

LECTURESHIP IN INDUSTRIAL ENGINEERING

1. The Lectureship in Engineering (with special reference to Industrial Engineering) shall henceforth be entitled the Lectureship in Industrial Engineering.
2. The Holder of the said Lectureship in Industrial Engineering shall carry out the duties of the Lectureship under the direction of the Professor of Industrial Engineering.
3. The Statutory provisions herein set forth shall be subsumed into the Conditions of Appointment and particulars of Duties of the existing Holders of; the foregoing Lectureship, the Professorship of Civil Engineering and the Professorship of Industrial Engineering who have assented in writing to such changes in the Conditions of Appointment and particulars of Duties attaching to their present posts as may be necessitated by the Statutory provisions herein set forth, THAT IS TO SAY:

Professor Michael E. J. O'Kelly, Professor of Industrial Engineering.

CHAPTER II

1. Nothing herein contained shall affect any appointment made, right acquired, or act done under any previous Statute of the College.
2. This Statute shall come into operation on the twenty-sixth day of March One Thousand Nine Hundred and Seventy-six and, may be cited as Statute CVII of University College, Galway or Stat. CVII Univ. Coll., Galway.
