STATUTE CXCI

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

SCHEDULE - STATUTE CXCI

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

- Notwithstanding anything contained in any previous Statute of the College, and particularly Statute CLXXXVIII, the stipends attached to fulltime Associate Professorships, Associate Secretaryships and fulltime Lectureships shall be increased as follows:
 - (a) By 53% as from the 1st day of December, 1986;
 - (b) By 2% as from the 1st day of January, 1987, in accordance with the provisions of the Agreement on Pay in the Public Service, 25th Pay Round.
 - (c) By 2% as from the 1st day of May, 1987, in accordance with the provisions of the Agreement on Pay in the Public Service, 25th Pay Round;

- (d) As from the 1st day of December, 1987, by an amount equivalent to the amount specified in respect of each post in Subsection (a) of this Section, increased by 2% as from the 1st day of January, 1987 and by 2% as from the 1st day of May, 1987, in accordance with the provisions of the Agreement on Pay in the Public Service, 25th Pay Round;
- (e) As from the 1st day of July, 1988 by an amount equivalent to the amount specified in respect of each post in Subsection (a) of this Section, increased by 2% as from the 1st day of January, 1987 and by 2% as from the 1st day of May, 1987 in accordance with the provisions of the Agreement on Pay in the Public Service, 25th Pay Round.
- 2. The foregoing increases shall be subject to and calculated in accordance with the provisions of the Agreement on Pay in the Public Service, 25th Pay Round.
- The Governing Body shall have power to round to the nearest pound the amounts of all stipends in which an increase is provided in this Statute.

CHAPTER II

- Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
- 2. This Statute shall come into operation on the fourteenth day of October, One Thousand Nine Hundred and Eighty-seven, and may be cited as Statute CXCI, University College, Galway, or Stat. CXCI, Univ. Coll., Galway.
