SCHEDULE- STATUTE CXXXV

All Statutes of University College, Galway, particularly the Statutes referred to in Chapter I of this Statute shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

The provisions of Chapter II of this Statute shall apply to the Part-time Lectureships following.

CHAPTER II

1. The foregoing Part-time Lectureships shall be Pensionable within the meaning of Chapter XXV of Statute XVII of University College, Galway and the amendments thereto and shall be annexed to the appropriate Table of the Pension Scheme. The Holder of the said Part-time Lectureships shall be entitled to payment of both Pension and Gratuity under and in accordance with the provisions of Chapter II and Chapter III of Statute XXXVI of University College, Galway and the Statutes of the College.
2. The annual stipends for the purpose of calculating Pensions and Gratuities in accordance with the relevant provisions of existing Statutes of the College shall be those payable at date of retirement or Death of the Holder pursuant to the provisions of the relevant sections of this Chapter.
3. The Holder of each of the Part-time Lectureships set out in Chapter I, shall have his years of service for Pension purposes calculated from the date of his appointment to the said Part-time Lectureship.
4. There shall be paid into the Pension Fund an additional sum equivalent to 15% of the stipend attaching to the Lectureship in respect of each year of pensionable service for the purpose of providing such pensions and gratuities as aforesaid.

CHAPTER III

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
2. This Statute shall come into operation on the seventeenth day of January, One Thousand Nine Hundred and Seventy-nine, and may be cited as Statute CXXXV, University College, Galway, or Stat. CXXXV, Univ. Coll., Galway
