STATUTE LXXV

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

SCHEDULE—STATUTE LXXV

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions, and modifications hereinafter set forth.

CHAPTER I

STIPENDS AND ALLOWANCES ATTACHED TO STATUTORY
PROFESSORSHIPS AND LECTURESHIPS

1. Notwithstanding anything contained in any previous Statute of the College the stipends (both as to stipends on appointment and as to maxima), annual increments and allowances (where applicable) attached to the Statutory Offices, Professorships, Associate Professorships, and Lectureships mentioned or referred to in any previous Statute of the College shall on and from the 1st day of June, 1968, be increased by nine per cent per annum PROVIDED that the Governing Body shall have power to round (upwards), to the nearest pound, the amounts of all stipends, increments and allowances.
2. This Chapter shall be deemed to have come into operation on the 31st day of May, 1968.

CHAPTER II

PENSIONS AND GRATUITIES

1. For the purpose of calculating the pension and gratuity respectively payable on the retirement and on the death or retirement of the President the annual stipend deemed to be payable to the President by Section 2 of Chapter 1 of Statute LXX of University College, Galway, shall be increased by nine per cent per annum.

For the purpose of calculating the pension and gratuity respectively payable on the retirement and on the death or retirement of the Lady Superintendent the annual stipend payable to her at date of retirement or at date of death shall be deemed to be £1,778.

2. Instead of the sum now being paid annually into the Statutory Pensionable Officers Pension Fund there shall henceforth be paid and transferred to the said Fund out of the annual income granted by the Oireachtas for the general purposes of the College or out of any other moneys of the College applicable thereto an annual sum of £37,000.
3. On coming into operation of this Statute, former holders of Pensionable Professorships, Pensionable Lectureships, or Pensionable Offices, shall be entitled to have their current pension calculated and paid in the manner and subject to the conditions prescribed by Statute LI of University College, Galway, subject to the provisions of Statute LXXII and (where applicable) of Statute LXVI and of Chapter I of Statute LXXIV of the said College.

CHAPTER III

MARRIAGE AND CHILDRENS' ALLOWANCES

1. Chapter 1 of Statute XXXVII of University College, Galway, is hereby amended by the substitution in Section 6 thereof of the figure "£82" for the figure "£40" mentioned therein. Chapter I of Statute LV of University College, Galway, is hereby amended as follows:—
 - (a) By the substitution in Section 2 of the figure "£56" for the figure "£40" mentioned therein ;
 - (b) By the substitution in Section 3 of the figure "£28" for the figure "£20" mentioned therein ;
 - (c) By the substitution in Section 4 of the figure "£21" for the figure "£15" mentioned therein.
2. This Chapter shall be deemed to have come into operation on the 31st day of May 1968 and the increased allowances set out in Section 1 thereof shall be payable on and from the 1st day of June 1968.

CHAPTER IV

STIPENDS ATTACHED TO STATUTORY OFFICES, PROFESSORSHIPS AND LECTURESHIPS

1. Notwithstanding anything contained in any previous Statute of the College, the stipends (both as to stipends on appointment and as to maxima) attached to the offices of the Secretary/Bursar, the Librarian, and to the full-time Professorships and to the full-time Lectureships of the College shall (in addition to the increase of nine per cent per annum granted by Section 1 of Chapter I of this Statute) on and from the 1st day of June 1968 be increased by £52 per annum.
2. Notwithstanding anything contained in any previous Statute of the College the stipends (both as to stipends on appointment and as to maxima) attached to the part-time Professorships and Lectureships mentioned or referred to in any previous Statute of the College shall (in addition to the increase of nine per cent per annum granted by Section I of Chapter I of this Statute on and from the 1st day of June 1968 be further increased by £26 per annum.

CHAPTER V

1. Nothing herein contained shall affect any appointment made, right acquired, liability incurred or act done under any previous Statute of the College.
2. This Statute shall come into operation on the Twenty-eighth day of March, One Thousand Nine Hundred and Sixty Nine and may be cited as Statute LXXV of University College, Galway, or Stat. LXXV Univ. Coll., Galway.
