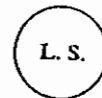

STATUTE XCIV

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

SCHEDULE—STATUTE XCIV

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions and modifications hereinafter set forth.

CHAPTER I

**STIPENDS AND ALLOWANCES ATTACHED TO
STATUTORY OFFICES, PROFESSORSHIPS AND
LECTURESHIPS**

From 1st June, 1973 until 30th June, 1973

1. Notwithstanding anything contained in any previous Statute of the College, the stipends (both as to stipends on appointment and as to maxima) and allowances attached to the Offices of Secretary/Bursar, Academic Secretary, Librarian, and to the full-time Professorships, Associate Professorships and Lectureships of the Collège shall, for the month of June 1973, be paid at the rates set forth in Table A of Chapter II of this Statute, reduced by £5.20 per annum.
2. Notwithstanding anything contained in any previous Statute of the College, the stipends attached to the part-time Professorships, Associate Professorships and Lectureships of the College shall, for the month of June 1973, be paid at the rates set forth in Table B of Chapter II of this Statute, reduced by £2.60 per annum.
3. This Chapter shall be deemed to have come into operation on the 31st May, 1973.

CHAPTER II
STIPENDS AND ALLOWANCES ATTACHED TO
STATUTORY OFFICES, PROFESSORSHIPS AND
LECTURESHIPS
From 1st July 1973

1. Notwithstanding anything contained in any previous Statute of the College, the stipends and allowances attached to the Offices, Professorships and Lectureships referred to in Table A and in Table B of this Chapter shall, on and from the first day of July 1973, be the stipends and allowances set forth in the said tables.
2. This Chapter shall be deemed to have come into operation on the 30th day of June, 1973.

TABLE A:

1. The annual stipend of the holder of each of the following full-time offices namely:
 - (a) The office of Secretary-Bursar,
 - (b) The office of Academic Secretary,
 - (c) The office of Librarian,
 shall be £4,827 on appointment, increasing to a maximum of £5,811 by annual increments of £123 for each completed year of service since appointment subject to the provisions where applicable of Chapter II of Statute LIV of University College, Galway.
2. The annual stipend of the holder of each full-time Professorship shall be £4,827 on appointment, increasing to a maximum of £5,811 by annual increments of £123 for each completed year of service since appointment subject to the provisions, where applicable, of Chapter II of Statute LIV of University College, Galway.
3. The annual stipend of the holder of each full-time Associate Professorship shall be £5,223. The said annual stipend shall be non-incremental.
4. The annual stipend of the holder of each full-time Lectureship shall be £3,450 on appointment increasing to a maximum of £4,590 by annual increments of £114 for each completed year of service since appointment subject to the provisions, where applicable, of Chapter II of Statute LIV of University College, Galway.

TABLE B:

1. The annual stipend of each part-time Professorship and each part-time Lectureship set out in this Table shall, as from the first day of July 1973, be the sum set opposite the respective titles of the said Professorships and Lectureships as follows:

CHAPTER III

PENSIONS AND GRATUITIES

1. For the purpose of calculating the pension and gratuity respectively payable on the retirement and on the death or retirement of the Lady Superintendent the annual stipend payable to her at date of retirement or at date of death, shall be deemed to be £3,807.
2. Instead of the sum now being paid annually into the Statutory Pensionable Officers' Pension Fund, there shall henceforth be paid and transferred to the said fund out of the annual Income granted by the Oireachtas for the general purposes of the College or out of any other monies of the College applicable thereto an annual sum equivalent to 15% of the basic salary of each Pensionable Officer.
3. On the coming into operation of this Statute, former holders of Pensionable Professorships, Pensionable Lectureships or Pensionable Offices shall be entitled to have their current pension calculated and paid in the manner and subject to the conditions prescribed by Statute LI of University College, Galway, subject to the provisions of Statute LXXII, Statute LXXX and (where applicable) of Statute LXVI and of Chapter I of Statute LXXIV.

CHAPTER IV

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
2. This Statute shall come into operation on the thirty-first day of October, One Thousand Nine Hundred and Seventy Three and may be cited as Statute XCIV of University College, Galway, or Stat. XCIV Univ. Coll., Galway.
