STATUTE XCVI

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

SCHEDULE—STATUTE XCVI

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions, and modifications hereinafter set forth.

CHAPTER I

STIPENDS ATTACHED TO FULL-TIME STATUTORY LECTURESHIPS

1. Notwithstanding anything contained in any previous Statute of the College, the stipends (both as to stipends on appointment and as to maxima), and annual increments attached to the full-time Lectureships mentioned or referred to in any previous Statute of the College shall, on and from the first day of December, 1972, be revised in accordance with Section 2 of this Chapter.
2. The Annual Stipend of the holder of each full-time Lectureship shall be the stipend at the following rates:—
  - (a) *From the first day of December, 1972 to the thirty-first day of December, 1972.*  
The Annual Stipend of the holder of each full-time Lectureship shall be £3,323 on appointment increasing to a maximum of £4,419 by annual increments of £137 for each completed year of service since appointment subject to the provisions, where applicable of Chapter II of Statute LIV of University College, Galway.

(b) *From the First day of January, 1973 to the thirty-first day of May, 1973.*

The Annual Stipend of the holder of each full-time Lectureship shall be £3,490 on appointment increasing to a maximum of £4,626 by annual increments of £142 for each completed year of service since appointment subject to the provisions, where applicable of Chapter II of Statute LIV of University College, Galway.

(c) *On and from the first day of June, 1973.*

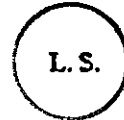
The Annual Stipend of the holder of each full-time Lectureship shall be £3,726 on appointment increasing to a maximum of £4,926 by annual increments of £150 for each completed year of service since appointment subject to the provisions, where applicable of Chapter II of Statute LIV of University College, Galway.

3. The stipends shown in 2(c) shall be reduced at a rate of £5.20 per annum for the month of June, 1973.

#### CHAPTER II

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
2. This statute shall come into operation on the thirty-first day of October, One Thousand Nine Hundred and Seventy three and may be cited as Statute XCVI of University College, Galway or Stat. XCVI Univ. Coll. Galway.
