STATUTE XCV

WE, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts DO by this present instrument under the Seal of University College, Galway, make the Statute contained in the Schedule hereto for the general government of the said College.

SCHEDULE—STATUTE XCV

All previous Statutes of University College, Galway, shall be read and construed with the alterations, additions, and modifications hereinafter set forth.

CHAPTER I

STIPENDS AND ALLOWANCES ATTACHED TO THE OFFICE OF PRESIDENT

1. Notwithstanding anything contained in any previous Statute of the College, the stipend and allowances attached to the office of President shall be the stipend and allowances at the following annual rates:
  - (a) *From the first day of June 1966 to the thirty-first day of December 1966*  
The Annual Stipend of the President shall be £4,767. In addition, he shall be entitled to residence, fuel and light as heretofore, valued for pension purposes at £742 p.a., and to a non-pensionable allowance of £742 p.a., in respect of the expenses of his office. The College shall be responsible for payment of the rates on the President's house.
  - (b) *From the first day of January 1967 to thirty-first day of May 1968*  
The Annual Stipend of the President shall be £5,572. In addition, he shall be entitled to residence, fuel and light as heretofore, valued for pension purposes at £900 p.a., and to a non-pensionable allowance of £900 p.a. in respect of the

expenses of his Office. The College shall be responsible for payment of the rates on the President's house.

- (c) *From the first day of June 1968 to the thirty-first day of May 1969*

The Annual Stipend of the President shall be £6,073. In addition, he shall be entitled to residence, fuel and light as heretofore, valued for pension purposes at £981 p.a., and to a non-pensionable allowance of £981 p.a. in respect of the expenses of his Office. The College shall be responsible for payment of the rates on the President's house.

- (d) *From the first day of June 1969 to the thirty-first day of March 1970*

The Annual Stipend of the President shall be £6,273. In addition, he shall be entitled to residence, fuel and light as heretofore, valued for pension purposes at £1,010 p.a., and to a non-pensionable allowance of £1,010 p.a., in respect of the expenses of his office. The College shall be responsible for payment of the rates on the President's house.

- (e) *From the first day of April 1970 to the thirtieth day of September 1970*

The Annual Stipend of the President shall be £6,712. In addition, he shall be entitled to residence, fuel and light as heretofore, valued for pension purposes at £1,081 p.a., and to a non-pensionable allowance of £1,081 p.a. in respect of the expenses of his Office. The College shall be responsible for payment of the rates on the President's house.

- (f) *From the first day of October 1970 to the thirty-first day of December 1970*

The Annual Stipend of the President shall be £7,048. In addition, he shall be entitled to residence, fuel and light as heretofore, valued for pension purposes at £1,135 p.a., and to a non-pensionable allowance of £1,135 p.a. in respect of the expenses of his office. The College shall be responsible for payment of the rates on the President's house.

- (g) *From the first day of January 1971 to thirty-first day of March 1971*

The Annual Stipend of the President shall be £7,706. In addition, he shall be entitled to residence, fuel and light as heretofore, valued for pension purposes at £1,241 p.a., and to a non-pensionable allowance of £1,241 p.a. in respect of the expenses of his Office. The College shall be responsible for payment of the rates on the President's house.

- (h) *From the first day of April 1971 to the thirty-first day of December 1971*

The Annual Stipend of the President shall be £8,091. In addition, he shall be entitled to residence, fuel and light as heretofore, valued for pension purposes at £1,303 p.a., and to a non-pensionable allowance of £1,303 p.a. in respect of the expenses of his Office. The College shall be responsible for payment of the rates on the President's house.

- (i) *From the first day of January 1972 to the thirty-first day of December 1972*

The Annual Stipend of the President shall be £8,195. In addition, he shall be entitled to residence, fuel and light as heretofore, valued for pension purposes at £1,303 p.a., and to a non-pensionable allowance of £1,303 p.a. in respect of the expenses of his Office. The College shall be responsible for payment of the rates on the President's house.

- (j) *From the first day of January 1973 to the thirty-first day of May 1973*

The Annual Stipend of the President shall be £8,556. In addition, he shall be entitled to residence, fuel and light as heretofore, valued for pension purposes at £1,355 p.a., and to a non-pensionable allowance of £1,355 p.a. in respect of the expenses of his office. The College, shall be responsible for payment of the rates on the President's house.

- (k) *From the first day of June 1973 to thirtieth day of June 1973*

The Annual Stipend of the President shall be £9,000.80. In addition, he shall be entitled to residence, fuel and light as heretofore, valued for pension purposes at £1,407 p.a., and to a non-pensionable allowance of £1,407 p.a. in respect of the expenses of his Office. The College shall be responsible for payment of the rates on the President's house.

- (l) *On and from the first day of July 1973*

The Annual Stipend of the President shall be £9,006. In addition, he shall be entitled to residence, fuel and light as heretofore, valued for pension purposes at £1,407 p.a. and to a non-pensionable allowance of £1,407 p.a. in respect of the expenses of his Office. The College shall be responsible for payment of the rates on the President's house.

2. Notwithstanding anything contained in any previous Statute of the College

- (a) for the purposes of calculating the pension payable on the retirement of the President, the annual stipend payable at date of retirement shall be deemed to be £10,413.

- (b) for the purposes of calculating the amount of gratuity payable at date of death or retirement of the President, the annual stipend payable shall be deemed to be £10,413.

## CHAPTER II

### STIPENDS ATTACHED TO STATUTORY OFFICES AND FULL-TIME PROFESSORSHIPS

Notwithstanding anything contained in any previous Statute of the College, the stipends (both as to stipends on appointment and as to maxima) attached to the Offices of Secretary/Bursar, Academic Secretary, and full-time Professorships shall be at the following annual rates:—

- (a) *From the first day of June 1966 to the thirty-first day of May 1968*

## CHAPTER III

## CHAPTER VII

## MARRIAGE ALLOWANCE

Section I of Chapter III and Section I of Chapter IV of Statute LXXXII of University College, Galway is hereby amended by the substitution of the following rates of Marriage Allowances for the figures mentioned in the said Chapters of Statute LXXXII:—

- (a) *From the first day of October 1970 to the thirty-first day of December 1970*  
£96 per annum
- (b) *From the first day of January 1971 to the thirty-first day of March 1971*  
£105 per annum
- (c) *From the first day of April 1971 to the thirty-first day of December 1972*  
£111 per annum
- (d) *From the first day of January 1973 to the thirty-first day of May 1973*  
£114 per annum
- (e) *On and from the first day of June 1973*  
£120 per annum

## CHAPTER VIII

## PENSIONS AND GRATUITIES

1. For the purpose of calculating the pension and gratuity respectively payable on the retirement and on the death or retirement of the Lady Superintendent the annual stipend payable to her at date of retirement or at date of death, shall be deemed to be £3,834.
2. Instead of the sum now being paid annually into the Statutory Pensionable Officers' Pension Fund, there shall henceforth be

paid and transferred to the said fund out of the annual Income granted by the Oireachtas for the general purposes of the College or out of any other monies of the College applicable thereto an annual sum equivalent to 15% of the basic salary of each Pensionable Officer.

3. On the coming into operation of this Statute, former holders of Pensionable Professorships, Pensionable Lectureships or Pensionable Offices shall be entitled to have their current pension calculated and paid in the manner and subject to the conditions prescribed by Statute LI of University College, Galway, subject to the provisions of Statute LXXII, Statute LXXX and (where applicable) of Statute LXVI and of Chapter I of Statute LXXIV.
4. Instead of the sum now being paid annually into Pension Fund No. 2 under Statute LXI of University College, Galway there shall henceforth be paid and transferred to the said fund out of the annual Income granted by the Oireachtas for the general purposes of the College or out of any other monies of the College applicable thereto an annual sum equivalent to 15% of the basic salary of each pensionable member of the staff included in this scheme.

#### CHAPTER IX

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the College.
2. This Statute shall come into operation on the thirty-first day of October, One Thousand Nine Hundred and Seventy Three and may be cited as Statute XCV of University College, Galway, or Stat. XCV Univ. Coll., Galway.
