STATUTE XXV.

We, the Governing Body of University College, Galway, under and by virtue of the powers in that behalf conferred on us by the said Act, do by this present instrument under the seal of University College, Galway, make the Statute contained in the Schedule hereof for the general government of the said College.

Given under the Common Seal of University College, Galway, this Ninth day of February, One Thousand Nine Hundred and Thirty-eight.

SCHEDULE.—STATUTE XXV.

1. All previous Statutes of University College, Galway, shall be read and construed with the amendments, additions, and modifications hereinafter set forth.

2. Section 2, Chapter XXV of Statute XVII of University College, Galway, is hereby amended by the deletion in said Section of all words from the words "on or before the 31st July, 1927" to the words "shall continue" and the insertion in said Section in lieu

thereof of the words "On or before the 31st July, 1938, and on or before the 31st July in each succeeding year thereafter, the sum of £1,110, with £300 additional so long as the additional income of the College shall continue" and the said Section shall be construed and have effect accordingly.

3. (a) Section 2 of Statute XXIV of University College, Galway, is hereby amended by the insertion after sub-section (8) thereof of a new sub-section as follows, that is to say:—

"(8) A. The annual pension shall be computed upon the basis of £6 5s. for each year of service in the offices following, namely:—The Lectureships through the medium of the Irish Language in (a) Mathematics; (b) History; (c) Education; (d) Ancient Classics; and (e) Economics, Commerce and Accountancy, and the years of service, for pension purposes, of the present holder of each of said offices shall be counted from the date of his first appointment."

(b) Sub-section (10) of Section 2 of said Statute XXIV is hereby amended by the insertion after paragraph V thereof of a new paragraph as follows, that is to say:—

"(10) V A. £50 to the Lecturers through the medium of the Irish Language in (a) Mathematics; (b) History; (c) Education; (d) Ancient Classics; and (e) Economics, Commerce and Accountancy, and the years of service, for the purposes of the gratuity, of the present holder of each of said offices shall be counted from the date of his first appointment."

(c) The said Section 2 of Statute XXIV shall be construed in accordance with the provisions of sub-sections (a) and (b) of this section and shall have effect accordingly.

4. (a) Section 3 of Statute XXIV of University College, Galway, is hereby amended by the insertion

after sub-section (8) thereof of a new sub-section as follows, that is to say ;—

“(8) A. The annual pension shall be computed upon the basis of £6 5s. for each year of service in the offices following, namely :—The Lectureships through the medium of the Irish language in (a) Mathematics ; (b) History ; (c) Education ; (d) Ancient Classics ; and (e) Economics, Commerce and Accountancy, and the years of service, for pension purposes, of the present holder of each of said offices shall be counted from the date of his first appointment.”

(b) Sub-section (10) of Section 3 of said Statute XXIV is hereby amended by the insertion after paragraph V thereof of a new paragraph as follows, that is to say :—

“(10) V A. £50 to the Lecturers through the medium of the Irish language in (a) Mathematics ; (b) History ; (c) Education ; (d) Ancient Classics ; and (e) Economics, Commerce and Accountancy, and the years of service, for the purpose of the gratuity, of the present holder of each of said offices shall be counted from the date of his first appointment.”

(c) The said Section 3 of Statute XXIV shall be construed in accordance with the provisions of sub-sections (a) and (b) of this Section and shall have effect accordingly.

5. (a) Section 17, Chapter XXV of said Statute XVII is hereby amended by the deletion in said Section of all words from the words “and shall be proved” to the end of the Section and the insertion in said Section in lieu thereof of the words “at its absolute discretion to grant to such officer or servant such pension or such gratuity as it may deem reasonable but out of funds other than the Pension Fund” and the said Section shall be construed and have effect accordingly.

(b) This Section shall be retrospective as and from the 1st October, 1934.

6. (1) This Statute shall be construed with and as part of Statute XX and said Statutes XVII and XXIV of University College, Galway, and it shall not affect any appointment made, right acquired, liability incurred, or act done under any previous Statute of the College.

(2) This Statute shall come into operation on the Ninth day of February, One Thousand Nine Hundred and Thirty-eight.

(3) This Statute may be cited as Statute XXV of University College, Galway, or Stat. XXV of Univ. Coll. Galway.
