1. Pursuant to Statute CCIII, Chapter I, Table A to Chapter I of Regulation 1/89 is hereby amended by the addition of the following subjects to the subjects set out under "Faculty of Arts" in the said Table:

Economics
 - Business Law
 - Common Law
 - Law including all other Law specialties
 - Mathematics, including Numerical Analysis and
Statistics
 - Mathematical Physics
