STATUTE CCCLXXXV/REACTH CCCLXXXV

WE, Údarás na hOllscoile of the University of Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of the University of Galway, make the Statute contained in the Schedule hereto for the general government of the said University./ *Faoi agus de bhua na gcumhachtaí sin a bheirtear dúinn ag na hAchtanna thuasluaite, DÉANAIMIDNE, Údarás na hOllscoile ag Ollscoil na Gaillimhe, tríd an ionstraim seo faoi Shéala Ollscoil na Gaillimhe, an Reacht atá sa Sceideal seo thíos chun rialú ginearálta na hOllscoile sin.*

Given under the Common Seal of University of Galway on this the Seventeenth Day of December, Two Thousand and Twenty Five/ *Arna thabhairt faoi Ghnáth-Shéala Ollscoil na Gaillimhe, an Seachtú Lá Déag seo de mhí na Nollag, Dhá Mhíle is Fiche a Cúig.*

Schedule – STATUTE CCCLXXXV/Sceideal – REACTH CCCLXXXV

All previous Statutes of University of Galway, and in particular Statutes CCCLXXI and CCCLXIX shall be read and construed with the alterations, additions and modifications hereinafter set forth./ *Déanfar Reachtanna uile Ollscoil na Gaillimhe, roimhe seo, agus go háirithe Reachtanna CCCLXXI agus CCCLXIX a léamh agus a fhorléiriú maille leis na hathruithe, na breisithe agus na modhnuithe atá leagtha amach ina dhiaidh seo thíos.*

CHAPTER I

UNIVERSITY MANAGEMENT TEAM

1. Statute CCCLXXI, Chapter I is hereby amended by the substitution of the following Section for Section 1 therein:

“There shall be a University Management Team, consisting of the President, the Deputy President & Registrar, the Bursar, the Vice-Presidents, the Chief Operating Officer, the Secretary for Governance & Academic Affairs, the Executive Deans and the Director of Human Resources. All members of the University Management Team shall report directly to the President, or as otherwise decided by the President.”

CHAPTER II

VICE PRESIDENTS

1. Statute CCCLXIX, Chapter 2 is hereby amended by the substitution of the following Section for Section 2 therein:

There are hereby established in the University up to five Offices of Vice-President. The title, role, and responsibilities of such Vice-Presidents shall be determined by Údarás na hOllscoile by regulation, on the recommendation of the President.

CHAPTER III

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.
2. This Statute shall come into operation on the Seventeenth day of December, Two Thousand and Twenty Five and may be cited as Statute CCCLXXXV, University Galway or Stat. CCCLXXXV, Univ. of Galway.

1. Déantar Reacht CCCLXXI, Caibidil I, a leasú leis seo tríd an alt seo a leanas a chur in áit Alt 1:

“Beidh Foireann Bainistíochta na hOllscoile ann, agus is iad sin an tUachtarán, an tUachtarán Ionaid & Meabhránaí, an Sparánaí, na Leas-Uachtaráin, an Príomhoifigeach Oibriúcháin, an Rúnaí Gnóthaí Rialachais & Acadúla, na Déin Feidhmiúcháin agus an Stiúrthóir Acmhainní Daonna. Beidh baill uile Fhoireann Bainistíochta na hOllscoile ag tuairisciú don Uachtarán, nó a mhalairt mar a chinneann an tUachtarán.”

CAIBIDIL II

LEAS-UACHTARÁIN

1. Déantar Reacht CCCLXIX, Caibidil 2, a leasú leis seo tríd an Alt seo a leanas a chur in áit Alt 2:

Bunaítear leis seo san Ollscoil cúig Oifig Leas-Uachtaránachta ar a mhéid. Déanfaidh Údarás na hOllscoile teideal, ról agus cúraimí na Leas-Uachtarán seo a chinneadh de réir rialacháin, ar mholadh an Uachtaráin.

CAIBIDIL III

1. Ní dhéanfaidh aon ní sa Reacht seo difear d'aon cheapachán a rinneadh, d'aon cheart a fuarthas ná d'aon ghníomh a rinneadh faoi aon Reacht Ollscoile roimhe seo.
2. Beidh feidhm leis an Reacht seo an Seachtú Lá Déag de mhí na Nollag, Dhá Mhíle is Fiche a Cúig agus féadfar é a lua mar Reacht CCCLXXXV, Ollscoil na Gaillimhe nó Reacht CCCLXXXV Oll. na Gaillimhe.
