STATUTE CCCLXXXIV/REACT CCCLXXXIV

WE, Údarás na hOllscoile of the University of Galway, under and by virtue of the powers in that behalf conferred on us by the above Acts, DO by this present instrument under the Seal of the University of Galway, make the Statute contained in the Schedule hereto for the general government of the said University./ *Faoi agus de bhua na gcumhachtaí sin a bheirtear dúinn ag na hAchtanna thuasluaite, DÉANAIMIDNE, Údarás na hOllscoile ag Ollscoil na Gaillimhe, tríd an ionstraim seo faoi Shéala Ollscoil na Gaillimhe, an Reacht atá sa Sceideal seo thíos chun rialú ginearálta na hOllscoile sin.*

Schedule – STATUTE CCCLXXXIV/Sceideal – REACT CCCLXXXIV

All previous Statutes of University of Galway, and in particular Statutes shall be read CCCLXXIX and CCCLXXII and construed with the alterations, additions and modifications hereinafter set forth./ *Déanfar Reachtanna uile Ollscoil na Gaillimhe roimhe seo, agus go háirithe Reachtanna CCCLXXIX agus CCCLXXII, a léamh agus a fhorléiriú maille leis na hathruithe, na breisithe agus na modhnuithe atá leagtha amach ina dhiaidh seo thíos.*

CHAPTER I
DEPUTY-PRESIDENT AND THE
REGISTRAR

Statute CCCLXXII Chapter 1 is hereby amended by the deletion of Section 2, sub-section c.

Statute CCCLXXIX Chapter 1 is hereby amended by the substitution of the following sections for Section 1 and Section 5 therein:

1. The Deputy-President and Registrar, acting under the general direction of the President, shall be shall be Chief Academic Officer and shall be responsible for providing academic oversight and for leadership of strategic projects as determined by the President, and shall do all such other acts and perform all such other duties in relation to the academic business of the University as she/he may be required by the President and by Údarás na hOllscoile to do or perform.
5. The Deputy-President and Registrar shall, subject to good conduct, a satisfactory one year probationary period, and due fulfilment of duties throughout the period of office, hold said office for a period of up to seven years or until he/she shall have obtained the mandatory public sector retirement age, whichever period shall first expire, each subject to the terms set out in the employment contract and job description.

CHAPTER II

1. Nothing herein contained shall affect any appointment made, right acquired or act done under any previous Statute of the University.
2. This Statute shall come into operation on the Seventeenth day of December, Two Thousand and Twenty Five and may be cited as Statute CCCLXXXIV, University Galway or Stat. CCCLXXXIV, Univ. of Galway.

AN tUACHTARÁN IONAIÐ AGUS MEABHRÁNAÍ

Déantar Reacht CCCLXXII Caibidil 1 a leasú, leis seo, trí Alt 2, fo-alt c a scriosadh.

Déantar Reacht CCCLXXIX, Caibidil 1, a leasú leis seo trí na hailt seo a leanas a chur in áit Alt 1 agus Alt 5:

1. Is é nó í an tUachtarán Ionaid agus Meabhránaí, ag gníomhú dó nó di faoi threoir ghinearálta an Uachtaráin, a bheidh ina P(h)ríomh-Oifigeach Acadúil; beidh sé nó sí freagrach as maoirseacht acadúil a thabhairt agus as ceannaireacht a thabhairt do thionscadail straitéiseacha arna threorú ag an Uachtarán; agus déanfaidh sé nó sí gach gníomh eile den sórt sin agus comhlíonfaidh sé nó sí gach dualgas eile den sórt sin maidir le gnó acadúil na hOllscoile de réir mar a iarrfaidh an tUachtarán agus Údarás na hOllscoile air nó uirthi a dhéanamh nó a chomhlíonadh.
5. Beidh an tUachtarán Ionaid agus Meabhránaí i seilbh na hoifige sin, faoi réir dea-iompair, tréimhse phromhaidh bliana shásúil a bheith caite aige nó aici, agus dualgais an phoist a bheith comhlíonta go cuí i rith na tréimhse oifige, ar feadh tréimhse suas le seacht mbliana nó go dtí go mbeidh an aois scoir dhlíthiúil don earnáil phoiblí bainte amach aige nó aici, cibé tréimhse díobh a rachaidh in éag i dtosach, agus gach ceann díobh faoi réir na dtéarmaí atá leagtha amach sa chonradh fostaíochta agus sa tsonraíocht phoist.

CAIBIDIL II

1. Ní dhéanfaidh aon ní sa Reacht seo difear d'aon cheapachán a rinneadh, d'aon cheart a fuarthas ná d'aon ghníomh a rinneadh faoi aon Reacht Ollscoile roimhe seo.
2. Beidh feidhm leis an Reacht seo an Seachtú Lá Déag de mhí na Nollag, Dhá Mhíle is Fiche a Cúig agus féadfar é a lua mar Reacht CCCLXXXIV, Ollscoil na Gaillimhe nó Reacht 384 Oll. na Gaillimhe.
